RESULTS OF OPERATIONS

The Fund's net assets decreased by \$2.8 million to \$9.5 million from March 31, 2024 to September 30, 2024. The Fund had net sales of \$0.6 million for the period. The portfolio's performance decreased assets by \$3.4 million. Series A units returned -27.7% after fees and expenses for the six-month period ended September 30, 2024. Over the same time period, the Fund's benchmark returned -27.3%. The benchmark is the Bloomberg Galaxy Ethereum Index (TR) (USD) (the Benchmark or the Index).

The performance of the Fund's other Series is substantially similar to that of Series A units, except for differences in the structure of fees and expenses. For the returns of the Fund's other Series, please refer to the "Past Performance" section.

The following commentary pertains to the results of operations of the CI Galaxy Ethereum ETF (the Underlying Fund).

Equities shifted course in the third quarter of 2024, with more breadth and volatility than the previous quarter. Index levels pushed higher after briefly pulling back in late July due to a weaker-than-expected labour market. New stimulus measures by China supported emerging markets, and U.S. interest rate policy controlled much of the narrative. The U.S. Federal Reserve Board held interest rates at 23-year highs in July but cut the federal funds rate by 50 basis points in September after some weakness in the labour market.

Ethereum underperformed U.S. equities, as measured by the S&P 500 Index and the Nasdaq 100 Index. Major U.S. asset managers launched Ethereum spot exchange-traded funds (ETFs), and the U.S. Securities and Exchange Commission approved options trading on Bitcoin ETFs. Bitcoin performance was largely flat over the period, and the launch of Ethereum ETFs in the United States did not attract enough attention to warrant a rally.

As a single-asset fund, the Underlying Fund's performance was driven solely by the performance of Ethereum.

We increased the Underlying Fund's position in Ethereum in line with share creations, and we trimmed the Underlying Fund's position in Ethereum in line with share redemptions.

Overall, the Fund slightly underperformed its benchmark for the period.

RECENT DEVELOPMENTS

The Underlying Fund's mandate is to track the performance of Ethereum. As such, the Underlying Fund's portfolio is weighted 100% to Ethereum.

Investor attention has turned to the upcoming U.S. presidential election, with prediction markets revealing no clear expected victor. And while the U.S. presidential election will most certainly influence all asset prices, including cryptocurrencies, investors are also monitoring global monetary easing as a likely boost for riskier assets. With volumes on Bitcoin options surging at \$100,000 strikes, cryptocurrency markets are pricing in high volatility heading into the fourth quarter of 2024.

Manager, Portfolio Adviser, Trustee and Registrar

CI Investments Inc. is the Manager, Portfolio Adviser, Trustee and Registrar of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration for management fees, provides management services required in the day-to-day operations of the Fund. The Manager bears all of the operating expenses of the Fund (other than taxes, borrowing costs and new governmental fees) in return for an administration fee.

The Manager received \$0.03 million in management fees and a nominal amount in administration fees for the period.

Management Fees

Approximately 25% of total management fees were used to pay for sales and trailing commissions. The remaining 75% of management fees were used to pay for investment management and other general administration.

Related fund trading occurs when a Fund purchases or sells units/shares of another Fund managed by the Manager. During the period/year ended September 30, 2024, the Fund engaged in related fund trading or held position(s) in related fund(s) at the end of the period/year.

Independent Review Committee

The Manager, in respect of the Fund, received the following standing instructions from the Independent Review Committee (IRC) with respect to related party transactions:

The applicable standing instructions require, amongst others, that related party transactions be conducted in accordance with the Manager's policies and procedures and applicable law and that the Manager reports related party transactions periodically to the IRC and advise the IRC of any material breach of such policies. The Manager's policies and procedures require that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; (c) do not exceed the limitations of the applicable legislation; and (d) achieve a fair and reasonable result for the Fund.

Except as otherwise noted above under Related Party Transactions section, the Fund was not a party to any related party transactions during the period/year ended September 30, 2024. If the Fund invested in related party transactions, it relied on the IRC's standing instructions regarding related party transactions during this reporting period/year.


