RESULTS OF OPERATIONS

The Fund's net assets increased by \$5.0 million to \$77.5 million from December 31, 2023 to June 30, 2024. The Fund had net sales of \$3.1 million for the period. The portfolio's performance increased assets by \$2.9 million. The Fund paid distributions totalling \$1.0 million. Hedged Common Units returned 3.3% after fees and expenses for the six-month period ended June 30, 2024. Over the same time period, the Fund's benchmark returned 13.7%. The benchmark is the MSCI World Total Return Index (LC) (the Benchmark or the Index).

Global equity markets got off to a strong start in 2024, with the MSCI ACWI Index gaining 13%, driven largely by the United States, which was up 19%. U.S. equities were particularly strong in the information technology sector, which appreciated almost 30%. Artificial intelligence (AI) adoption boosted spending and investment, benefiting U.S. companies and potentially driving growth in China and India. Corporate earnings driven by technological advancements continued to support equity returns.

Signs of a slowdown in economic activity appeared as restrictive monetary policies worked their way through major developed economies with long and variable lags. While U.S. economic growth continued to outperform its peers, a softening became evident in the second quarter of 2024.

While the U.S. Federal Reserve Board left its policy interest rate on hold in June 2024, the global monetary easing cycle began. Central banks elsewhere, including the European Central Bank, the Riksbank (Sweden) and the Swiss National Bank, lowered their key policy interest rates in response to slowing economic growth and moderating inflationary pressures.

Disappointing U.S. inflation data led to fears of a reacceleration during the first quarter of 2024 and resulted in a significant decrease in expectations for interest rate cuts relative to the start of the year. However, more recent data revealed that price pressures were moderating. U.S. labour market data was mixed, but the trend also suggested a slowing.

Election results in Mexico, India, South Africa and Europe had surprising outcomes, triggering considerable repricing across local financial markets. Elections in the United Kingdom and France in particular showed how quickly the political landscape can change.

The Fund underperformed its benchmark over the period. The Fund's allocations to consumer discretionary, energy and materials detracted from performance. The largest individual detractors from the Fund's performance were positions in Intel Corp., Enphase Energy Inc. and First Solar Inc.

Exposures to the health care, consumer staples and information technology sectors contributed to the Fund's performance. Top individual contributors to the Fund's performance included holdings in NVIDIA Corp., Novo Nordisk AS and Amgen Inc.

Any notable changes made to the Fund's holdings during the year were related to rebalancing activity. Portfolios are obtained from Morningstar and rebalanced as per their direction with respect to constituents and weightings. The Fund's management fee is 35 basis points.

From an environmental, social and governance (ESG) perspective, approximately 90% of the Fund's holdings scored an "A" or "AA" ESG rating, indicating the company was a leader in the space. Overall, 53% of holdings were characterized as Governance Leaders and constituents were largely free of reputational risk related to environmental, customer, human rights, labour or governance issues.

The Fund had a high level of exposure to companies that scored well in Overall Sustainable Impact, Environmental Impact and Social Impact. The Fund's weighted average exposure of each company's percent of revenue generated by Environmental Impact goods and services was 32.2%, with the largest contributors being green buildings (10.2%), energy efficiency (8.0%) and alternative energy (7.0%). Smaller contributions were made by companies deriving revenue from activities related to sustainable water, pollution prevention and sustainable agriculture.

The Fund's weighted average exposure of each company's percent of revenue generated by Social Impact goods and services was 29.0%, with the largest contributors being major diseases treatment (15.1%), sanitation (5.2%) and nutrition (6.9%). Smaller contributions were made by companies deriving revenue from activities related to affordable real estate.

RECENT DEVELOPMENTS

We are cautiously optimistic as we look toward the second half of 2024. Equity markets have been buoyed by the prospect of interest rate cuts by leading central banks as well as the enthusiasm for all things related to the Al boom. We see indications of softer economic activity due to weakening of consumer spending trends. Softer economic growth along with moderating inflationary trends are the leading arguments for lower interest rates. Any extension of the higher interest rate environment may lead to a recalibration of equity valuations.

There is a risk that softer economic activity could coincide with sticky rates of inflation during a period of political volatility. This must be balanced against the prospect of accelerating economic growth, particularly in regions and sectors benefiting from technological innovation and infrastructure investments. The adoption of Al has widespread implications for spending and investment not only within the information technology supply chain but also within those sectors and companies that will benefit from greater efficiency gains. Equity performance for those companies exposed to these developments have benefited U.S. companies, but economies like China and India could see strong equity performance fuelled by recoveries in consumption and advancement in their technological developments. Increased spending from the Asia-Pacific region would help promote growth globally.

Political developments, including elections and policy changes, have also been influencing global markets. Uncertainty surrounding elections in various regions has prompted a more cautious tone among investors and added to market volatility. We expect volatility to persist through the election cycle. Within the Fund, diversification and a strategic approach to regional and sector allocation based on prevailing economic and corporate conditions will be crucial in navigating the evolving market landscape.

Manager, Portfolio Manager and Trustee

CI Investments Inc. is the Manager, Portfolio Manager and Trustee of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration of management fees, provided management services required in the day-to-day operations of the Fund.

The Manager's policies and procedures require that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; (c) do not exceed the limitations of the applicable legislation; and (d) achieve a fair and reasonable result for the Fund.

Except as otherwise noted above under Related Party Transactions section, the Fund was not a party to any related party transactions during the period/year ended June 30, 2024. If the Fund invested in related party transactions, it relied on the IRC's standing instructions regarding related party transactions during this reporting period/year.


