### **INVESTMENT OBJECTIVE AND STRATEGIES**

The investment objective of CI Conservative Income Personal Portfolio (the Fund) is to provide investors with current income and capital preservation with the potential for long-term capital appreciation by investing prudently in an actively managed, diversified portfolio of global equity and fixed-income securities of companies, either directly or indirectly, of all capitalizations, including those involved in the real estate, infrastructure, energy and materials sectors.

The equity component will range between 10 - 50% of the Fund's portfolio, while the fixed-income component will range between 50 - 90%. The fixed-income portion of the portfolio will include directly or indirect investment in a combination of high-yield fixed-income securities and investment-grade fixed-income securities of any type and will maintain an average credit rating of BBB or higher. The Fund may invest up to all of the Fund's assets in securities of other mutual funds, including those managed by the CI Investments Inc., and may invest up to all of its assets in foreign securities.

The Fund currently achieves its investment objective by investing all of its assets in multiple underlying mutual funds (the Underlying Funds).

For a complete discussion of the Fund's and the Underlying Funds' respective investment objective and strategies, please refer to the Fund's and the Underlying Funds' most recently filed simplified prospectus.

#### RISK

The Manager reviews the risk rating for the Fund on an annual basis, at a minimum, based on the methodology mandated by the Canadian Securities Administrators to determine the risk level of the Fund. Any change to the risk rating made during the period/year was as a result of such review and was not a result of any change to the investment objective, strategies or management of the Fund.

## **RESULTS OF OPERATIONS**

The Fund's net assets decreased by \$19.0 million to \$87.1 million from March 31, 2022 to March 31, 2023. The Fund had net redemptions of \$9.3 million during the year. The portfolio's performance decreased assets by \$3.4 million. The Fund paid distributions totalling \$6.3 million. Series A units returned -3.3% after fees and expenses for the one-year period ended March 31, 2023. Over the same time period, the Fund's benchmark returned -0.8%. The benchmark is a combination of the FTSE Canada Universe Bond Total Return Index - 65% and the MSCI World Total Return Index - 35% (the Benchmark or the Index).

The performance of the Fund's other Series is substantially similar to that of Series A shares, except for differences in the structure of fees and expenses. For the returns of the Fund's other Series, please refer to the "Past Performance" section.

The following commentary pertains to the results of operations of the Underlying Funds.

Central banks around the world continued to raise interest rates throughout the year. Headline inflation (i.e., Consumer Price Index) readings dropped moderately in the latter months of the year, but core measures remained elevated. This led central banks to act aggressively in their tightening of monetary policies. The Canadian and U.S. government bond yield curves began to invert as the year unfolded, in anticipation of weaker economic growth. Economic growth did slow in most interest rate-sensitive sectors as higher borrowing costs and tighter financial conditions impacted spending. However, labour markets remained tight, with low unemployment and strong nominal wage gains.

The Fund underperformed its benchmark for the year. An overweight allocation to the real estate sector detracted from the Fund's performance. Security selection in the real estate and materials sectors also detracted from the Fund's performance.

The Fund's duration (sensitivity to interest rates) strategy within its fixed-income holdings contributed to its performance. Exposure to high-yield bonds contributed to the Fund's performance as their higher running yield helped to offset the rise in government bond yields. Within the Fund's equity component, stock selection in the financials and consumer discretionary sectors contributed to performance.

We increased the Fund's existing core and high-yield bond positions within its fixed-income component. The Fund's exposure to U.S. equities was trimmed, and the Fund's global real estate exposure was reduced.

### RECENT DEVELOPMENTS

We expect a further slowing of the economy, with a likely recession in 2023. Therefore, our positioning of the Fund will be biased toward longer-duration assets, with only tactical shifts and less exposure to credit.

#### Administrator

Effective November 14, 2022, RBC Investor Services Trust ceased acting as the administrator to the Fund and CIBC Mellon Global Securities Services Company started acting as the administrator to the Fund.

### Independent Review Committee

Effective October 6, 2022, John Sheedy became a member of the Independent Review Committee (IRC) of CI Funds.

#### Risk rating

Effective June 21, 2022, the risk rating for the Fund changed from "Low" to "Low-to-Medium". This change is the result of an annual review to comply with the methodology mandated by the Canadian Securities Administrators and is not the result of any changes to investment objective, strategies or management of the Fund.

#### **RELATED PARTY TRANSACTIONS**

### Manager, Portfolio Advisor and Registrar

CI Investments Inc. is the Manager, Portfolio Advisor and Registrar of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration for management fees, provides management services required in the day-to-day operations of the Fund. The Manager bears all of the operating expenses of the Fund (other than borrowing and interest costs, investor meeting costs (as permitted by Canadian securities regulation), the fees and expenses of the Independent Review Committee, the fees, costs and expenses associated with compliance with any new governmental and regulatory requirements imposed on or after February 16, 2018 and new governmental fees or with any changes to existing governmental and regulatory requirements imposed on or after February 16, 2018 (including increases to regulatory filing fees), any new types of costs, expenses or fees not incurred prior to February 16, 2018, including those arising from new government or regulatory requirements or related to those external services that were not commonly charged in the Canadian mutual fund industry as of February 16, 2018, and operating expenses that were or are outside the normal course of business of the Fund on or after February 16, 2018) in return for an administration fee.

Approximately 31% of total management fees were used to pay for sales and trailing commissions. The remaining 69% of management fees were used to pay for investment management and other general administration.

The applicable standing instructions require, amongst others, that related party transactions be conducted in accordance with the Manager's policies and procedures and applicable law and that the Manager reports related party transactions periodically to the IRC and advise the IRC of any material breach of such policies. The Manager's policies and procedures require that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager, uninfluenced by considerations other than the best interests of the Fund; (c) do not exceed the limitations of the applicable legislation; and (d) achieve a fair and reasonable result for the Fund.

Except as otherwise noted above under Related Party Transactions section, the Fund was not a party to any related party transactions during the period/year ended March 31, 2023. If the Fund invested in related party transactions, it relied on the IRC's standing instructions regarding related party transactions during this reporting period/year.



#### **Annual Compound Returns**

The following table shows the Fund's annual compound returns for each year indicated, compared to the Blended Index composed of: (65% - FTSE Canada Universe Bond Total Return Index and 35% - MSCI World Total Return Index); the FTSE Canada Universe Bond Total Return Index and the MSCI World Total Return Index.

The MSCI World Index is a free float-adjusted market capitalization weighted index that is designed to measure the equity market performance of developed markets. The Index consists of the following 23 developed market country indices: Australia, Austria, Belgium, Canada, Denmark, Finland, France, Germany, Hong Kong, Ireland, Israel, Italy, Japan, Netherlands, New Zealand, Norway, Portugal, Singapore, Spain, Sweden, Switzerland, the United Kingdom and the United States of America.

The FTSE Canada Universe Bond Index is a market capitalization weighted index that measures the performance of the Canadian investment-grade fixed income market. The Index consists of fixed rate bonds denominated in Canadian dollars, with a remaining effective term to maturity of at least one year, rated BBB or higher. The Index is comprised of four main credit or borrower categories: bonds issued by the Government of Canada (including Crown Corporations), Provincial bonds (including provincially-guaranteed securities), Municipal bonds and Corporate bonds. The Corporate sector is further divided into sub-sectors based on major industry groups: Financial, Communication, Industrial, Energy, Infrastructure, Real Estate and Securitization. The Corporate sector is also divided into sub-indices based on credit rating: a combined AAA/AA sector, a single A sector and a BBB sector.

A discussion of the performance of the Fund as compared to the benchmark is found in the Results of Operations section of this report.
