INVESTMENT OBJECTIVE AND STRATEGIES

The investment objective of Sentry Alternative Asset Income Fund (the Fund) is to provide regular income and long-term capital appreciation by investing primarily in a diversified portfolio of securities with exposure to alternative asset classes including global real estate and infrastructure and fixed-income securities. The Fund seeks to maintain exposure to real estate, infrastructure and fixed income securities, generally in the range of 10% to 40% each. The real estate portion of the Fund's portfolio may include real estate investment trusts, common equities and convertible debentures of those businesses that own, manage, develop, finance or otherwise participate in the residential or commercial real estate industry. The infrastructure portion of the Fund's portfolio may include securities of publicly listed global companies with either a direct or indirect exposure to infrastructure. The Fund may invest in any kind of fixed-income security, including those considered high yield, and may invest in other income-oriented equity securities. The Fund has the ability to invest up to all of its assets in foreign securities. For a complete discussion of the Fund's investment objective and strategies, please refer to the Fund's most recently filed simplified prospectus.

RISK

No changes affecting the overall level of risk associated with investing in the Fund were made during the year. The risks of the Fund remain as discussed in the Fund's most recently filed simplified prospectus or its amendments. The Manager reviews the risk rating for the Fund on an annual basis, at a minimum, based on the methodology mandated by the Canadian Securities Administrators to determine the risk level of the Fund. Any change to the risk rating made during the year was as a result of such review and was not a result of any change to the investment objective, strategies or management of the Fund.

RESULTS OF OPERATIONS

The net asset value of the Fund decreased by \$16.5 million to \$42.8 million from March 31, 2018 to March 31, 2019. The Fund had net redemptions of \$15.7 million during the year. The portfolio's performance increased assets by \$2.4 million. The Fund paid distributions totalling \$3.2 million. Series A units returned 4.4% after fees and expenses for the one-year period ended March 31, 2019. Over the same time period, the Fund's benchmark returned 11.2%. The benchmark is a combination of the ICE BofAML Global High Yield Total Return Index - 25.0%, the FTSE EPRA/NAREIT Developed Total Return Index - 25.0%, the S&P Global Infrastructure Total Return Index - 25.0%, the Cboe S&P 500 BuyWrite Total Return Index - 12.5% and the Cboe S&P 500 PutWrite Total Return Index - 12.5%.

The performance of the Fund's other Series is substantially similar to that of Series A units, except for differences in the structure of fees and expenses. For the returns of the Fund's other Series, please refer to the "Past Performance" section.

After the elevated volatility and tighter financial conditions of the fourth quarter of 2018, central banks around the globe, led by the U.S. Federal Reserve (Fed) are now in retreat. Policy reassessment is underway with a pivot away from containing cyclical inflation to countering secular deflation. The Government of Canada bond and U.S. Treasury curves are now inverted, and the market is now pricing in an interest rate cut from the Fed. The European Central Bank and Bank of Japan will likely not begin their tightening cycles at all. Importantly, funding channels remains open and real economic data is proving resilient, and even rebounding in China.

The Fund underperformed its benchmark for the year. U.S. dollars and T-bills posted as collateral on the options strategy (in-the-money puts and covered calls) were a drag on relative performance but contributed positive returns if viewed accurately paired with the options trades.

Brookfield Asset Management Inc. was a top contributor to performance during the year, reflecting its continued success in fundraising, as well as a macro shift to a lower yield environment supportive of valuations for hard assets.

During the year, we added a Fund position in Inter Pipeline Ltd. 6.875% hybrid bonds due 2079, which are rated BBB- by Standard & Poor's. We found this new issue attractive as it closes the cash burn on the construction of the company's new petrochemical plant in Alberta. We also added new bonds to the Fund from Scientific Games Corp. (8.25% bonds due 2026 and rated Caa1/B-) as our existing position in the company's 10% bonds due 2022 was called at a premium.

On the equities side, we re-established a position in renewable power producer Northland Power Inc. and started a position in Spanish financial services provider Banco Santander S.A.

We also swapped our position in Kinder Morgan Canada Ltd. into Kinder Morgan Inc. to mitigate regulatory issues.

Portfolio dispositions were largely limited to bonds being called or partial calls for refinancing.

On the equities side, we exited the Fund's position in Swedbank AB.

RECENT DEVELOPMENTS

The high-yield market is much improved from the previous quarter with new issuance and inflows to the asset class particularly strong in this quarter. Our base case suggests further spread tightening is possible, but it would come from Treasury yields backing

up rather than high-yield bond prices appreciating. Hence, the expectation of "clipping our coupon" will yield a very respectable high-single to low-double-digit return for the year, which is our base assumption. Equity valuations, especially in high carry sectors such as real estate and infrastructure, can also provide a lift given the macroeconomic environment. This is consistent with our view that a Fed holding on interest rate hikes and a decelerating, but still positive economic growth very much supports the carry trade. Volatility seems to be adjusting, or 'normalizing' slower than government bond yields as such option-writing strategies should provide attractive premiums.

New Accounting Standard - IFRS 9

Effective April 1, 2018, the Fund retrospectively without restatement adopted IFRS 9, Financial Instruments (IFRS 9). The new standard requires financial assets to be either carried at amortized cost or at fair value with changes in fair value recognized in profit and loss (FVTPL) or in other comprehensive income (FVOCI) based on the Fund's business model for managing financial assets and the contractual cash flow characteristics of the financial assets. Upon transition to IFRS 9, the Fund's financial assets and financial liabilities previously designated as FVTPL or classified as held for trading under IAS 39, Financial Instruments: Recognition and Measurement (IAS 39) continue to be classified as FVTPL under IFRS 9. There were no changes in the measurement attributes for any of the Fund's financial assets and financial liabilities upon transition to IFRS 9.

On June 1, 2018, Sentry Investments Inc. amalgamated with CI Investments Inc. (CI) and Sentry Investments Corp. After the amalgamation, members of the Independent Review Committee (IRC) of the CI family of funds also became members of the Sentry Funds' IRC (together, the CI Funds IRC). Previous members of the Sentry Funds' IRC resigned on May 31, 2018.

On September 1, 2018, the Administration Fee proposal that was approved by unitholders during a special meeting held on May 3, 2018 came into effect. Effective September 1, 2018, CI Investments Inc. bears all of the operating expenses of the Fund (other than taxes, borrowing costs and new governmental fees) in return for the Administration Fee. Further details about the Administration Fee can be found in the Fund's most recent simplified prospectus and annual information form or their amendments at www.sedar.com.

Effective September 20, 2018, Tom Eisenhauer became a member of the CI Funds' IRC, and effective October 15, 2018, Mary Robertson resigned as a member of the CI Funds' IRC.

RELATED PARTY TRANSACTIONS

Manager, Portfolio Advisor and Trustee

CI Investments Inc. is the Manager, Portfolio Advisor and Trustee of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration for management fees, provides management services required in the day-to-day operations of the Fund. The Manager bears all of the operating expenses of the Fund (other than borrowing and interest costs, investor meeting costs (as permitted by Canadian securities regulation), the fees and expenses of the Independent Review Committee, the fees, costs and expenses associated with compliance with any new governmental and regulatory requirements imposed on or after February 16, 2018 and new governmental fees or with any changes to existing governmental and regulatory requirements imposed on or after February 16, 2018 (including increases to regulatory filing fees), any new types of costs,

expenses or fees not incurred prior to February 16, 2018, including those arising from new government or regulatory requirements or related to those external services that were not commonly charged in the Canadian mutual fund industry as of February 16, 2018, and operating expenses that were or are outside the normal course of business of the Fund on or after February 16, 2018) in return for a fixed administration fee.

The Manager received \$0.7 million in management fees and \$0.1 million in fixed administration fees for the year.

During the year ended March 31, 2019, the Manager of the Fund absorbed \$21,000 in management fees.

Management Fees

Approximately 27% of total management fees were used to pay for sales and trailing commissions. The remaining 73% of management fees were used to pay for investment management and other general administration.

Inter-Fund Trading

Inter-fund trading occurs when a Fund purchases or sells a security of any issuer from or to another Fund managed by the Manager. These transactions are executed through market intermediaries and under prevailing market terms and conditions. The Independent Review Committee reviews such transactions during scheduled meetings. During the year ended March 31, 2019 the Fund executed inter-fund trades.

Independent Review Committee

The Fund received standing instructions from the Fund's Independent Review Committee with respect to the following related party transactions:

a) trades in securities of CI Financial Corp.; and

b) purchases or sales of securities of an issuer from or to another investment fund managed by the Manager.

The applicable standing instructions require that related party transactions be conducted in accordance with the Manager's policies and procedures and that the Manager advise the IRC of any material breach of a condition of the standing instructions. The standing instructions require, among other things, that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; (c) are made in compliance with the Manager's policies and procedures; and (d) achieve a fair and reasonable result for the Fund. Transactions made by the Manager under the standing instructions are subsequently reviewed by the IRC on a quarterly basis to monitor compliance.

The Fund relied on the IRC's standing instructions regarding related party transactions during this reporting year.

Except as otherwise noted above, the Fund was not a party to any related party transactions during the year ended March 31, 2019.

The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a higher turnover rate and the performance of a Fund. Portfolio turnover rate is calculated by dividing the lesser of the cost of purchases and the proceeds of sales of portfolio securities for the year, and excluding cash and short-term investments maturing in less than one year, and before assets acquired from a merger, if applicable, by the average of the monthly fair value of investments during the year.




PAST PERFORMANCE

Annual Compound Returns

The following table shows the Fund's annual compound returns for each year indicated, compared to the Blended Index composed of: (25.0% - FTSE EPRA/NAREIT Developed Total Return Index, 25.0% - ICE BofAML Global High Yield Total Return Index, 25.0% - S&P Global Infrastructure Total Return Index, 12.5% - Cboe S&P 500 BuyWrite Total Return Index and 12.5% - Cboe S&P 500 PutWrite Total Return Index, the FTSE EPRA/NAREIT Developed Total Return Index, the ICE BofAML Global High Yield Total Return Index, the S&P Global Infrastructure Total Return Index, the Cboe S&P 500 BuyWrite Total Return Index and the Cboe S&P 500 PutWrite Total Return Index.

The FTSE EPRA/NAREIT Developed Index is a free float-adjusted capitalization weighted index, which is designed to track the performance of listed real estate companies and REITS.

The ICE BofAML Global High Yield Index tracks the performance of USD, CAD, GBP and EUR denominated below investment grade corporate debt publicly issued in the major domestic or eurobond markets.

The S&P Global Infrastructure Index is designed to track 75 companies from around the world chosen to represent the listed infrastructure industry while maintaining liquidity and tradability. To create diversified exposure, the Index includes three distinct infrastructure clusters: energy, transportation and utilities.

The Cboe S&P 500 BuyWrite Index is a benchmark index designed to track the performance of a hypothetical buy-write strategy on the S&P 500 Index.

The Cboe S&P 500 PutWrite Index measures the performance of a hypothetical portfolio that sells S&P 500 Index put options against collateralized cash reserves held in a money market account. The price history for the Cboe S&P 500 PutWrite Index extends back to June 30, 1986.
