INVESTMENT OBJECTIVE AND STRATEGIES

The investment objective of the CI Global Equity Momentum Private Pool (the Fund) is to provide long-term capital growth by investing primarily in a diversified portfolio of equity and equity-related securities of companies located anywhere in the world which are believed to offer above-average growth potential.

The Fund will primarily invest in a diversified portfolio of equity and equity-related securities of companies located anywhere in the world, exhibiting positive fundamental change and offering above-average growth potential. Equity-related securities include convertible preferred shares, convertible debt obligations and warrants. The portfolio advisor has broad discretion to select investments with minimal limitation regarding sector weightings, market capitalization, individual position size or consideration of the composition of benchmark indices. It is expected that the Fund will generally have between 40 to 60 equity or equity-related holdings.

When selecting securities for the Fund, the portfolio advisor utilizes both independent quantitative models and fundamental analysis to identify companies exhibiting positive fundamental change more rapidly than the overall stock market.

A quantitative model assists in identifying stocks that exhibit such characteristics including, but not limited to, earnings acceleration, upward changes in analysts' earnings forecasts and positive earnings surprises. Independently, the major fundamental aspects of each company are analyzed from a fundamental perspective including, but not limited to, the quality of the company's earnings streams and how it is positioned to benefit from the current economic environment.

The portfolio advisor will typically seek to be rewarded by significant upward movements in stock prices that can occur over shorter time periods. The Fund is also continuously monitored with the objective of quickly identifying companies with deteriorating fundamentals, so they can be sold before their relative performance declines significantly. Since change is a catalyst, the Fund will typically have a higher portfolio turnover rate than less actively managed funds.

RISK

No changes affecting the overall level of risk associated with investing in the Fund were made during the year. The risks of the Fund remain as discussed in the Fund's most recently filed simplified prospectus or its amendments. The Manager reviews the risk rating for the Fund on an annual basis, at a minimum, based on the methodology mandated by the Canadian Securities Administrators to determine the risk level of

the Fund. Any change to the risk rating made during the year was as a result of such review and was not a result of any change to the investment objective, strategies or management of the Fund.

RESULTS OF OPERATIONS

The Fund's net assets increased by \$5.0 million to \$11.6 million from March 31, 2020 to March 31, 2021. The Fund had net sales of \$1.7 million during the year. The portfolio's performance increased assets by \$3.6 million. The Fund paid distributions totalling \$0.3 million. Series A units returned 51.0% after fees and expenses for the one-year period ended March 31, 2021. Over the same time period, the Fund's benchmark returned 38.2%. The benchmark is the MSCI World Total Return Index (the Benchmark or the Index).

The performance of the Fund's other Series is substantially similar to that of Series A units, except for differences in the structure of fees and expenses. For the returns of the Fund's other Series, please refer to the "Past Performance" section.

The COVID-19 pandemic created a unique backdrop resulting in a shutdown of the economy and significant fiscal and monetary policy intervention. E-commerce companies were among those that benefited from stay-at-home orders, but some companies, such as mall operators, saw the pandemic end their prospects for future viability. Positive vaccine news and rollout success led investors to shift focus toward stocks that are expected to benefit from the economy re-opening. With stimulus in place, inflationary concerns became front and center with investors and longer-term yields began to move. This can lead to investors' shift out of growth-at-any-price stocks in favour of more cyclical exposures.

The Fund outperformed its benchmark for the year largely as a result of stock selection. The Fund's underweight allocations to the consumer staples, utilities and real estate sectors contributed to performance. Overweight positions in the consumer discretionary, information technology and industrials sectors also contributed to performance. Top individual contributors to the Fund's performance included PayPal Holdings Inc. and NIO Inc. PayPal Holdings Inc.'s payment volumes soared through 2020 as the world shifted rapidly to e-commerce amid the global pandemic. We believe that habits formed during the crisis are likely to linger and new product launches and use cases are likely to keep users engaged. NIO Inc. benefited from supportive government policies, strong Chinese consumer perception of the company and improving competitiveness against Tesla Inc.

The Fund's cash allocation detracted from performance during a period of strong equity market performance. Underweight positions in the materials and health care sectors detracted from the Fund's performance. The largest individual detractors from performance were holdings in Apple Inc. and Tesla Inc., and a lack of exposure to

The Home Depot Inc., which saw strong performance. Another notable detractor from performance was Corestate Capital Holding SA, which was challenged by the pandemic. Sales slowed considerably over the past few months, which has raised questions about its mezzanine business, which accounts for about 25% of revenue and generates high returns.

We added a new position in Royal Mail PLC, which delivered strong results in parcels and increased letter volume, and better cost controls. An existing position in Redrow PLC was increased. Intuitive Surgical Inc. was eliminated from the Fund, while Microsoft Corp. was trimmed.

RECENT DEVELOPMENTS

With unprecedented monetary and fiscal stimulus, global economic growth is likely to accelerate in 2021. We believe that an inventory rebuild cycle and an upswing in the hard-hit services sector should result from the vaccine rollout, and help to unleash pent-up consumer demand. This means there is likely to be more room for equities to rise. The U.S. Federal Reserve remains steadfast in its positioning not to raise interest rates. However, longer-term interest rates could prove concerning and as such, monitoring inflationary data points will be key. Supply and demand imbalances mean commodity prices could keep trending higher. Sustained fiscal and monetary stimulus support the notion that inflation may remain, and to the extent that it does, sooner-than-expected interest-rate increases seem plausible.

We favour the materials sector, commodity-exposed companies in particular, and believe they will help to protect against potential inflationary pressures. At the same time, we have reduced the Fund's information technology exposures, especially those with higher valuations as higher interest rates may significantly impact their discounted cash flow.

CI Investments Inc. rebrands as CI Global Asset Management Inc.

On November 10, 2020, CI Investments Inc. announced that it is rebranding to CI Global Asset Management Inc. The rebrand is underway and is scheduled to be completed by the end of the first quarter of 2021. With the rebrand, legacy in-house investment boutique brands will be phased out and they will operate under CI Global Asset Management. The affected brands are Cambridge Global Asset Management, Harbour Advisors, Sentry Investment Management, and Signature Global Asset Management.

RELATED PARTY TRANSACTIONS

Manager, Portfolio Advisor, Trustee and Registrar

CI Investments Inc. is the Manager, Portfolio Advisor, Trustee and Registrar of the Fund. CI Investments Inc. is a subsidiary of CI Financial Corp. The Manager, in consideration for management fees, provides management services required in the day-to-day operations of the Fund. The Manager bears all of the operating expenses of the Fund (other than taxes, borrowing costs and new governmental fees) in return for an administration fee.

The Manager received \$0.01 million in management fees and a nominal amount in administration fees for the year.

Management Fees

Approximately 26% of total management fees were used to pay for sales and trailing commissions. The remaining 74% of management fees were used to pay for investment management and other general administration.

Independent Review Committee

The Fund has received standing instructions from the Fund's IRC to make or hold an investment in the security of an issuer related to the Manager.

The applicable standing instructions require, amongst others, that related party transactions be conducted in accordance with the Manager's policies and procedures and applicable law and that the Manager advise the IRC of any material breach of such policies. The standing instructions also require that investment decisions in respect of related party transactions (a) are free from any influence by an entity related to the Manager and without taking into account any consideration relevant to an entity related to the Manager; (b) represent the business judgment of the Manager uninfluenced by considerations other than the best interests of the Fund; (c) are made in compliance with the Manager's policies and procedures; and (d) achieve a fair and reasonable result for the Fund. Quarterly, the IRC reviews reports which assess compliance with applicable CI policies. Annually, the IRC reviews reports describing each instance that the Manager acted in reliance on the standing instructions noted above.

(4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the fiscal year. The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a higher turnover rate and the performance of a Fund. Portfolio turnover rate is calculated by dividing the lesser of the cost of purchases and the proceeds of sales of portfolio securities for the year, and excluding cash and short-term investments maturing in less than one year, and before assets acquired from a merger, if applicable, by the average of the monthly fair value of investments during the year.

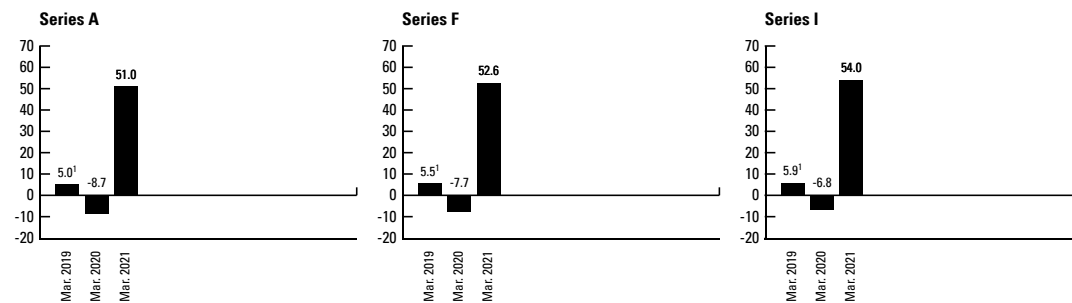
