



Invesco Main Street U.S. Small Cap Class' - Series PTF

This document contains key information you should know about Invesco Main Street U.S. Small Cap Class (the "Fund"). You can find more detailed information in the Fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

Notice: On January 13, 2026, Invesco Canada Ltd. (the "Manager") announced that it has entered into a definitive agreement to sell the management agreements relating to its Canadian fund business to CI Investments Inc., operating as CI Global Asset Management ("CI GAM"). Under the terms of the agreement and subject to the receipt of all necessary consents and approvals, CI GAM will become the investment fund manager and portfolio manager of the Fund (the "Transaction").

The Transaction is subject to receipt of applicable regulatory approvals as well as satisfaction of other customary closing conditions. The change in manager of the Fund is subject to approval by securityholders of the Fund (collectively, "Securityholders"). The Manager has called a special meeting of Securityholders to consider the change of manager, which is expected to be held on or about April 13, 2026. Should the Fund not obtain the requisite Securityholder approval, the Fund will be terminated. Assuming satisfaction of all approvals and conditions, the Transaction is expected to close by the end of the second quarter of 2026.

The Fund invests in common shares and other equity securities of U.S. companies with a small market capitalization.

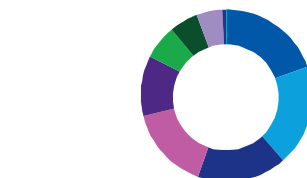

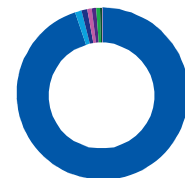

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

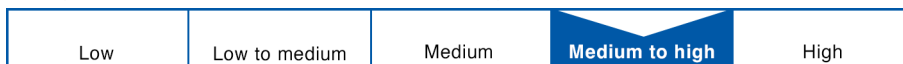
One way to gauge the risk is to look at how much a fund's returns change over time. This is called "volatility."

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Invesco Canada Ltd. has rated the volatility of this Fund as **Medium to high**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

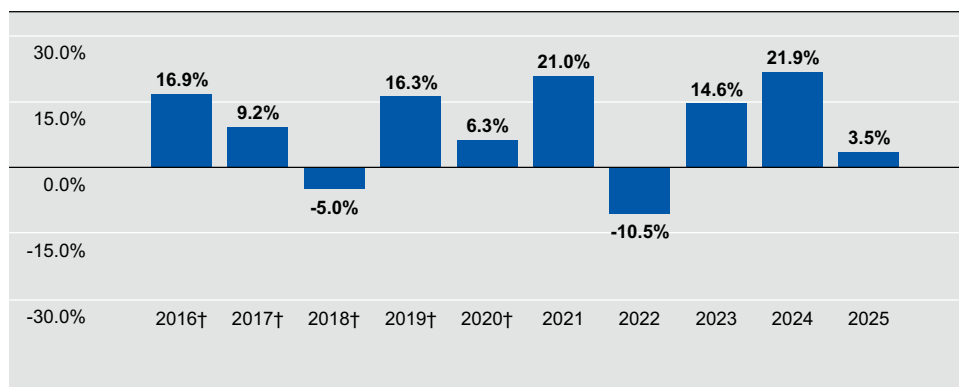
Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the Fund performed?

This section tells you how Series PTF shares of the Fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how Series PTF shares of the Fund performed in each of the past 10 years. The Fund dropped in value in two of the 10 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



† On October 15, 2020, the Fund's investment strategies were changed. The performance of the Fund for the period prior to this date would have been different had the current investment strategies been in place during that period.

Best and worst three-month returns

This table shows the best and worst returns for the Series PTF shares of the Fund in a three-month period over the past 10 years. The best and worst three-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series PTF shares of the Fund 10 years ago now has \$2,347. This works out to an annual compound return of 8.91%.

Who is this Fund for?

Investors who:

- Want strong capital growth over the long term
- Own, or plan to own, other types of investments to diversify their holdings
- Want a specialty U.S. equity investment
- Are comfortable with medium to high risk

The Fund is not appropriate if you have a short-term investment horizon.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether you hold the fund in a registered plan, such as a registered retirement savings plan or a tax-free savings account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series PTF shares of the Fund. The fees and expenses, including any commissions, can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are no sales charges for Series PTF shares of the Fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As of September 30, 2025, the expenses of Series PTF were 1.02% of the value of this series. This equals \$10.20 for every \$1,000 invested.

More about the trailing commission

Invesco Canada Ltd. does not pay trailing commissions in respect of Series PTF shares of the Fund.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch Series PTF shares of the Fund.

Fee	What you pay
Short-term trading fee	If you redeem or switch within 30 days of purchase, Invesco Canada Ltd. reserves the right to charge, on behalf of the Fund, a short-term trading fee of 2% on top of any other fees that may apply.
Investment advisory fee	You may buy and hold this series of shares in an account where you pay for advice directly to your representative's firm (in whatever form agreed to between you and your representative's firm), rather than through Invesco Canada Ltd. (either directly or indirectly). Your representative's firm may charge you an investment advisory fee which you negotiate with your representative.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document,

or

- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase or, in some jurisdictions, claim damages if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities legislation in your province or territory.
