What does the fund invest in?

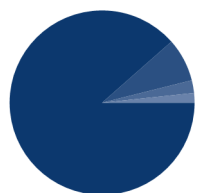
The fund invests in the CI Canadian Bond Fund. The underlying fund invests mostly in Canadian bonds.

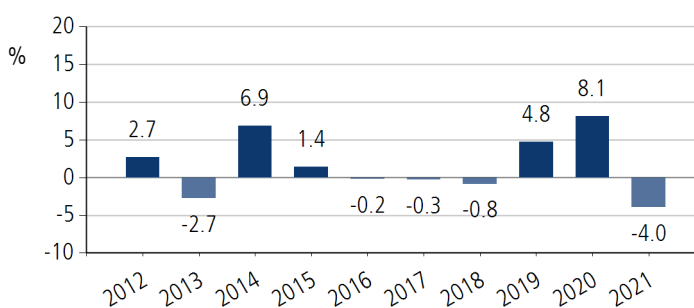
How has the fund performed?

Average return

This section tells you how the fund did in the past. A person who invested \$1,000 in the no-load fund in December 2011 would have \$1,161.68 in December 2021. This works out to an average of 1.51% each year. The returns are after the MER has been deducted. The MER of the segregated fund includes insurance fees. The insurance fees and other costs will reduce the returns of the fund. Past returns do not tell you how the fund will do in the future. Your return will vary based on your guarantee option and personal tax situation.

Ongoing Fund expenses
