CI Conservative Income Personal Portfolio (Series B5 units) December 19, 2023

This document contains key information you should know about CI Conservative Income Personal Portfolio (the "fund"). You can find more details in the fund's simplified prospectus. Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.

CI Global Asset Management proposes to change the investment objective of the fund, as well as its name to CI Mosaic Balanced Income ETF Portfolio Class on or about April 12, 2024. For further information, please see Amendment No. 1 to the simplified prospectus of the fund dated June 23, 2023.

If approved at a special meeting of the fund to be held on or about March 20, 2024, the investment objective of the fund will be changed to provide a balance between income and long-term capital growth, with a bias towards income, by investing primarily in a diversified portfolio of fixed income and equity exchange-traded funds. Pending the approval of the investment objective change, the fund series' management fee and administration fee will be reduced to 1.45% and 0.15%, respectively.

What does the fund invest in?

CI Conservative Income Personal Portfolio aims to provide current income and capital preservation with the potential for capital appreciation by investing prudently in an actively managed, diversified portfolio of global equity and fixed-income securities.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk Rating

CI Global Asset Management has rated the volatility of this fund as low to medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.



How has the fund performed?

This section tells you how Series B5 securities of the fund have performed over the past 8 calendar year(s). Returns are after expenses have been deducted. These expenses reduce the fund's returns. Effective April 1, 2016, Series T5 securities purchased under the DSC, LL or LL2 sales charge options were re-designated as Series B5. The performance data shown below includes the performance for Series T5 prior to April 1, 2016.

Year-by-year returns

This chart shows how Series B5 securities of the fund performed in each of the past 8 calendar year(s). This fund series dropped in value in 2 of the last 8 calendar year(s). The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series B5 securities of the fund in a 3-month period over the past 8 calendar year(s). The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As at October 31, 2023, a person who invested \$1,000 in Series B5 securities of the fund since inception has \$1,181. This works out to an annual compounded rate of return of 1.8%.

Who is this fund for?

This fund may be suitable for you if you:

- are willing to accept a low to medium degree of risk
- are seeking a regular source of current income with the potential for capital appreciation
- are seeking to add global exposure to your investment portfolio
- are planning to hold your investment for the long term

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

You will not have to pay income tax on any return of capital distributions made by the fund, although they will affect your capital gains or losses on disposition.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series B5 securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You can no longer buy Series B5 securities of the fund. However, you can switch to Series B5 securities of the fund under the deferred sales charge option or low load sales charge option if you already hold securities purchased under such options of a fund managed by us. The deferred sales charge schedule will be based on the date you bought the first fund, and the rates and duration of such schedule shall continue to apply.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund series' returns.

As of September 30, 2023, the expenses of Series B5 of the fund were 2.46% of its value. This equals \$24.60 for every \$1,000 invested.

After the applicable redemption fee schedule in respect of the deferred sales charge option or low load sales charge option is complete, your Series B5 securities will be automatically switched, on a quarterly basis following the date the applicable redemption fee schedule is complete, to Series T5, which will (a) have the same or lower combined management and administration fee, (b) qualify for management fee reductions based on the level of assets invested, and (c) not be subject to a deferred / low load redemption fee.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own Series B5 securities of the fund. It is for the services and/or advice that your representative and their firm provide to you. CI Global Asset Management pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. Upon the automatic switch of Series B5 securities to Series T5 securities, your representative may receive a trailing commission of up to 1.00% of the value of your investment each year.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Short-term trading fee	A fee of up to 2.00% of the value of securities you redeem or switch, if we determine that you have engaged in inappropriate short-term trading. This fee goes to the fund.
Switch fee	Your representative's firm may charge you up to 2.00% of the value of securities you switch to another mutual fund managed by us.
Program minimum fee	If you participate in one of our managed programs, we may charge you an annual fee of up to 0.15% of the net asset value of the applicable series of securities of the fund within the program, payable to us quarterly by the redemption of securities (without charges), if your investment is less than the program minimum.
Reclassification fee	If you are switching Series A, Series AH, Series T, Series B or Series BT securities to a different series of securities of the same fund, you may have to pay to us a reclassification fee if you bought your securities under a DSC option, IDSC option, or LL option, as applicable. The reclassification fee is equal to the redemption fee you would pay if you redeemed your securities.
NSF cheque fee	We will charge you \$25 if a payment for a purchase of securities is returned by your bank for any reason.
