# CI Corporate Bond Class - Series B January 12, 2024

This document contains key information you should know about CI Corporate Bond Class (the "fund"). You can find more details in the fund's simplified prospectus. Effective November 1, 2023, the management fee of Series B of the fund was reduced from 1.20% to 1.05%, which may have resulted in a reduction in the MER of this series going forward. You can find more information about the management fees in the fund's simplified prospectus.

#### What does the fund invest in?

CI Corporate Bond Class's investment objective is to provide investors with a return that is similar to the return of Signature Corporate Bond Fund, or another North American and/or international bond fund managed by us (the "Reference Fund"). The investment objective of the Reference Fund is to achieve a yield advantage by using fundamental value analysis to evaluate investments by investing mainly in fixed income securities that are investment grade and below investment grade.

The charts below give you a snapshot of the Reference Fund's investments on November 30, 2023. The Reference Fund's investments will change.

# How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### **Risk Rating**

CI Global Asset Management has rated the volatility of this fund as low.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.


# **CI Corporate Bond Class - Series B**

### How has the fund performed?

This section tells you how Series B securities of the fund have performed over the past 10 calendar year(s). Returns are after expenses have been deducted. These expenses reduce the fund's returns. Effective April 1, 2016, Series A securities purchased under the DSC or LL options were re-designated as Series B. The performance data shown below includes the performance for Series A prior to April 1, 2016.

### Year-by-year returns

This chart shows how Series B securities of the fund performed in each of the past 10 calendar year(s). This fund series dropped in value in 2 of the last 10 calendar year(s). The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for Series B securities of the fund in a 3-month period over the past 10 calendar year(s). The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As at November 30, 2023, a person who invested \$1,000 in Series B securities of the fund 10 years ago has \$1,281. This works out to an annual compounded rate of return of 2.5%.

## Who is this fund for?

# This fund may be suitable for you if you:

- · are willing to accept a low degree of risk
- are seeking a source of regular income and the potential for long-term capital appreciation
- are planning to hold your investment for the long term

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# **CI Corporate Bond Class - Series B**

### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series B securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You can no longer buy Series B securities of the fund. However, you can switch to Series B securities of the fund under the deferred sales charge option or low load sales charge option if you already hold securities purchased under such options of a fund managed by us. The deferred sales charge schedule will be based on the date you bought the first fund, and the rates and duration of such schedule shall continue to apply.

#### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund series' returns.

As of September 30, 2023, the expenses of Series B of the fund were 1.58% of its value. This equals \$15.80 for every \$1,000 invested.

After the applicable redemption fee schedule in respect of the deferred sales charge option or low load sales charge option is complete, your Series B securities will be automatically switched, on a quarterly basis following the date the applicable redemption fee schedule is complete, to Series A, which will (a) have the same or lower combined management and administration fee, (b) qualify for management fee reductions based on the level of assets invested, and (c) not be subject to a deferred / low load redemption fee.

#### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own Series B securities of the fund. It is for the services and/or advice that your representative and their firm provide to you. CI Global Asset Management pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. Upon the automatic switch of Series B securities to Series A securities, your representative may receive a trailing commission of up to 0.75% of the value of your investment each year.

#### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Short-term trading fee	A fee of up to 2.00% of the value of securities you redeem or switch, if we determine that you have engaged in inappropriate short-term trading. This fee goes to the fund.
Switch fee	Your representative's firm may charge you up to 2.00% of the value of securities you switch to another mutual fund managed by us.
Program minimum fee	If you participate in one of our managed programs, we may charge you an annual fee of up to 0.15% of the net asset value of the applicable series of securities of the fund within the program, payable to us quarterly by the redemption of securities (without charges), if your investment is less than the program minimum.
Reclassification fee	If you are switching Series A, Series AH, Series T, Series B or Series BT securities to a different series of securities of the same fund, you may have to pay to us a reclassification fee if you bought your securities under a DSC option, IDSC option or LL option, as applicable. The reclassification fee is equal to the redemption fee you would pay if you redeemed your securities.
NSF cheque fee	We will charge you \$25 if a payment for a purchase of securities is returned by your bank for any reason.

#### What if I change my mind?

Under the securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you will also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
