#### What does the fund invest in?

CI U.S. Equity Class seeks a balance of current income and long-term capital appreciation by investing substantially all of its assets in securities of CI U.S. Equity Fund. The underlying fund invests primarily in a diversified portfolio of dividend-paying U.S. equity securities, including common and preferred shares and, to a lesser extent, interest bearing securities, such as bonds, bills or bankers' acceptances.

#### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

# **Risk Rating**

CI Global Asset Management has rated the volatility of this fund as medium.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.


# CI U.S. Equity Class - Series O

#### How has the fund performed?

This section tells you how Series O securities of the fund have performed over the past 3 calendar year(s). Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how Series O securities of the fund performed in each of the past 3 calendar year(s). This fund series dropped in value in 1 of the last 3 calendar year(s). The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for Series O securities of the fund in a 3-month period over the past 3 calendar year(s). The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As at April 28, 2023, a person who invested \$1,000 in Series O securities of the fund since inception has \$1,545. This works out to an annual compounded rate of return of 10.8%.

# Who is this fund for?

#### This fund may be suitable for you if you:

- are willing to accept a medium degree of risk
- are seeking a regular source of income and the potential for capital appreciation
- · are seeking to add U.S. exposure to your investment portfolio
- · are planning to hold your investment for the long term

# A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O securities of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

#### 1. Sales charges

No sales charge is paid when you own Series O securities of the fund.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund series' returns.

As of March 31, 2023, the expenses of Series O of the fund were 0.17% of its value. This equals \$1.70 for every \$1,000 invested.

# More about the trailing commission

No trailing commission is paid to your representative's firm when you own Series O securities of the fund.

# 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Short-term trading fee	A fee of up to 2.00% of the value of securities you redeem or switch, if we determine that you have engaged in inappropriate short-term trading. This fee goes to the fund.
Switch fee	Your representative's firm may charge you up to 2.00% of the value of securities you switch to another mutual fund managed by us.
NSF cheque fee	We will charge you \$25 if a payment for a purchase of securities is returned by your bank for any reason.
Series O management fee	Management fees are paid directly by you to us. The management fee for Series O securities of the fund is up to 0.90% of the net asset value of your investment in the series. Management fee reductions may apply in certain circumstances, for more information, please speak with your representative.
Series O service fee	You may be charged a Series O service fee, the amount of which is negotiated between you and your representative (acting on behalf of the representative's firm) and may be collected by us on behalf of your representative's firm (by redeeming (without charges) a sufficient number of securities from your account on a quarterly basis). The Series O service fee must not exceed 1.25% annually of the net asset value of Series O securities of the fund in your account.
