Subject to obtaining all necessary regulatory and securityholder approvals, CI Investments Inc. proposes to merge the fund into Cambridge Growth Companies Fund (to be renamed Cambridge Global Smaller Companies Fund) on or after November 22, 2019. What does the fund invest in?

This fund invests primarily in common shares of Canadian companies. The fund may invest up to 49% of its assets in foreign market investments.



How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

CI Investments Inc. has rated the volatility of this fund as medium.

Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.



How has the fund performed?

This section tells you how Class P securities of the fund have performed over the past 1 calendar year. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Class P securities of the fund performed in the past 1 calendar year. This fund class dropped in value in 1 of the last 1 calendar year. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Class P securities of the fund in a 3-month period over the past 1 calendar year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

	Return	3 months ending	If you invested \$1,000 at the beginning of the period
Best return	6.3%	May 31, 2018	Your investment would be \$1,063.
Worst return	-14.2%	December 31, 2018	Your investment would be \$858.

Average return

The annual compounded return of Class P securities of the fund was 0.8% since inception. If you had invested \$1,000 in the fund on the inception date, your investment would now be worth \$1,020.

Who is this fund for?

This fund may be suitable for you if you:

- are seeking growth of capital associated with Canadian equity securities
- are investing for the medium and/or long term
- can tolerate medium risk

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws of where you live and whether you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class P securities of the fund. The fees and expenses — including any commissions — can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are no sales charges applicable to your class of securities.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund class' returns. As at March 31, 2019, the total fund class' expenses were 0.36%. This equals \$3.60 for every \$1,000 invested.

Management expense ratio (MER) This is the total of the fund class' administration fee and Certain Fund Costs.	0.22%
Trading expense ratio (TER) These are the fund class' trading costs.	0.14%
Fund expenses	0.36%

More about trailing commission

CI Investments Inc. does not pay a trailing commission on your class of securities out of the fund's management fee.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

Fee	What you pay
Short-term trading fee	Up to 2% of the net asset value of the securities you redeem, if we determine that you have engaged in inappropriate short-term trading, which may occur if you sell or transfer your securities within 30 days of buying them. This fee goes to the fund.
Transfer fee	Your representative's firm may charge you up to 2% of the net asset value of securities you switch to another fund.
Investment advisory fee	You may be charged an investment advisory fee, the amount of which is negotiated between you and your representative (acting on behalf of the representative's firm) and collected by us on behalf of your representative's firm (by redeeming (without charges) a sufficient number of securities from your account on a quarterly basis). The investment advisory fee must not exceed 1.25% annually of the net asset value of Class P securities in the fund in your account.
Class P management fee	You will be charged a management fee directly by us and payable directly to us quarterly by the redemption of securities (without charges). The maximum management fee to be charged is 1.00% annually of the net asset value of Class P securities in the fund in your account. Management fee reductions may apply in certain circumstances, for more information, please speak with your representative.
NSF cheque fee	There is a \$25 charge for all cheques returned because of insufficient funds.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the limit set by the securities law in your province or territory.
