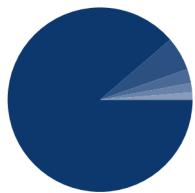
The Fund invests in the CI American Value Corporate Class. The underlying fund invests mostly in U.S. shares.

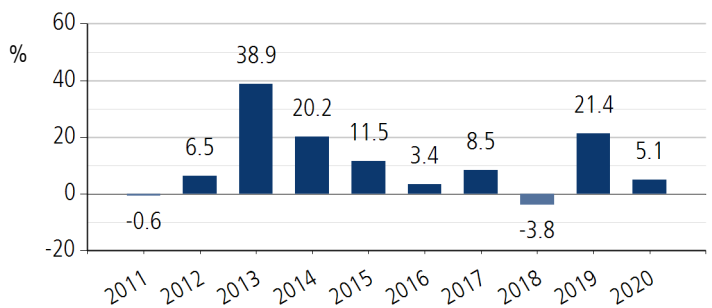
#### How has the Fund performed?

##### Average return

Your return will vary based on your guarantee option and personal tax situation.
