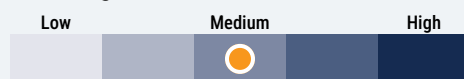
## FUND OVERVIEW

The Index is comprised of the 300 companies in the WisdomTree Dividend Index with market capitalization of at least US\$2 billion, with the best combined rank of growth and quality factors.

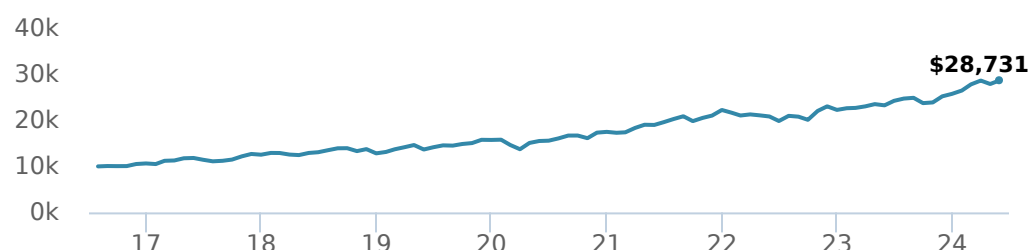

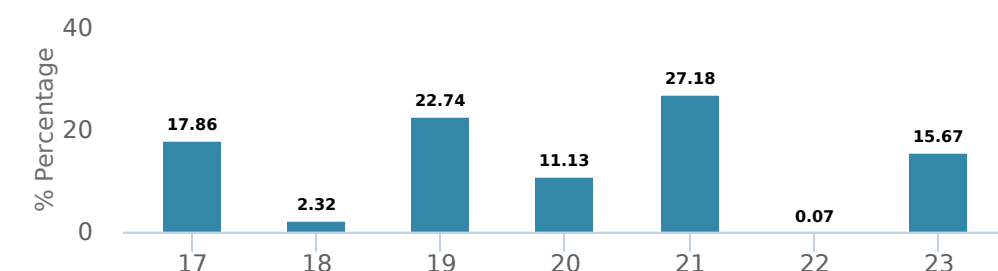

Average annual compound returns

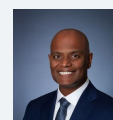
