The leverage will be calculated in accordance with the methodology prescribed by securities regulations, or any exemptions therefrom.

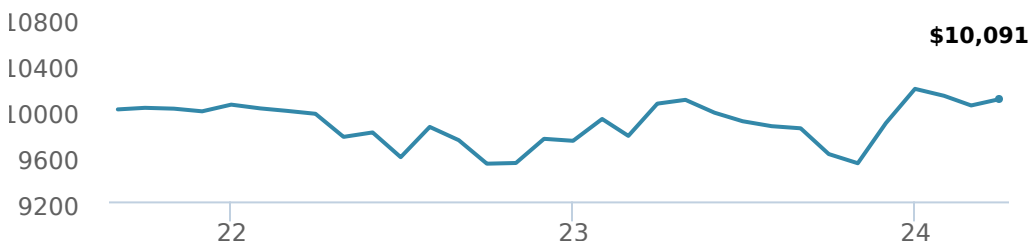

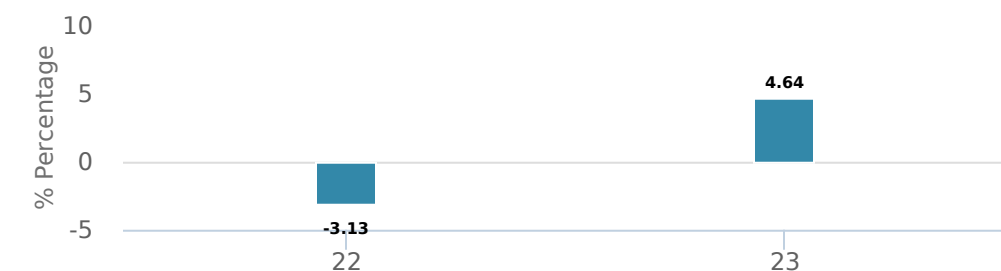
