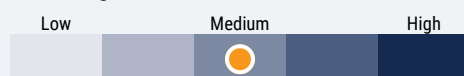
## FUND OVERVIEW

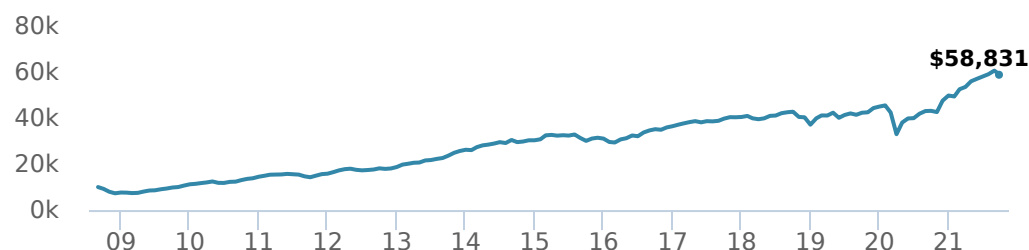

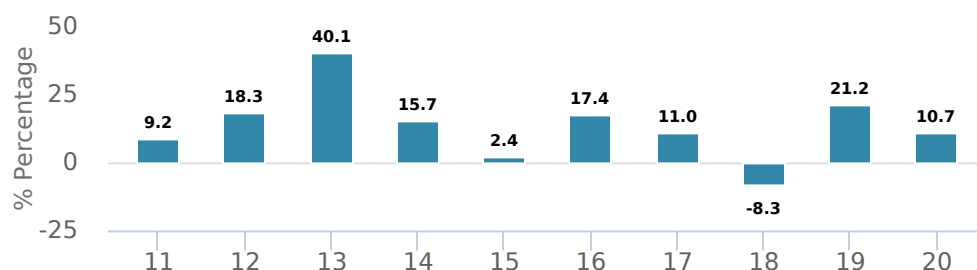
