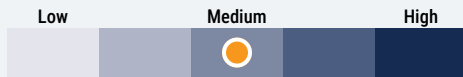
## FUND OVERVIEW

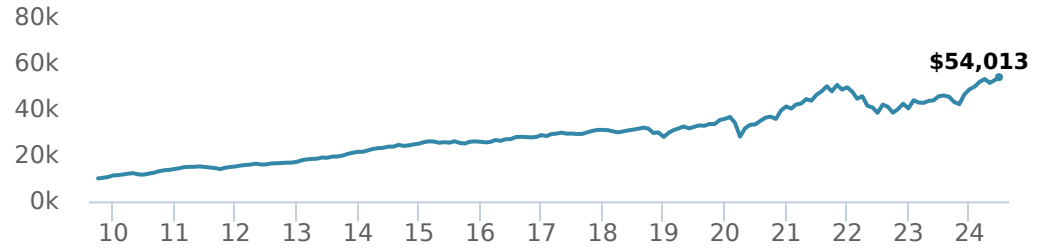

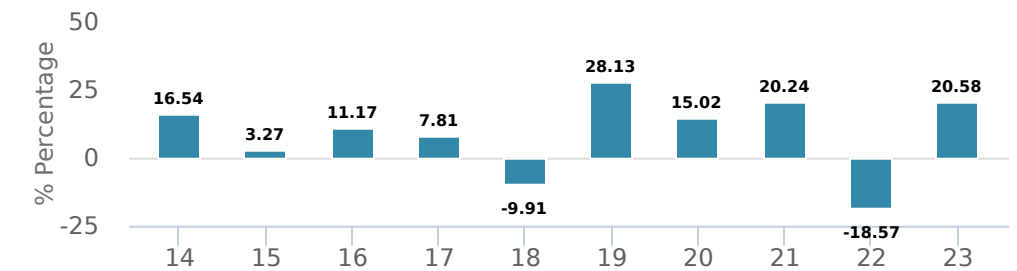

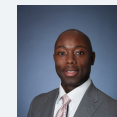
