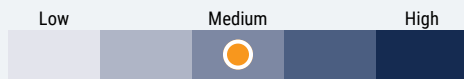
## FUND OVERVIEW

## Risk rating<sup>1</sup>



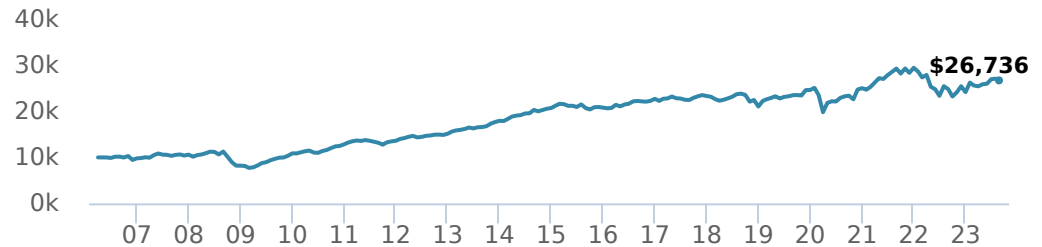

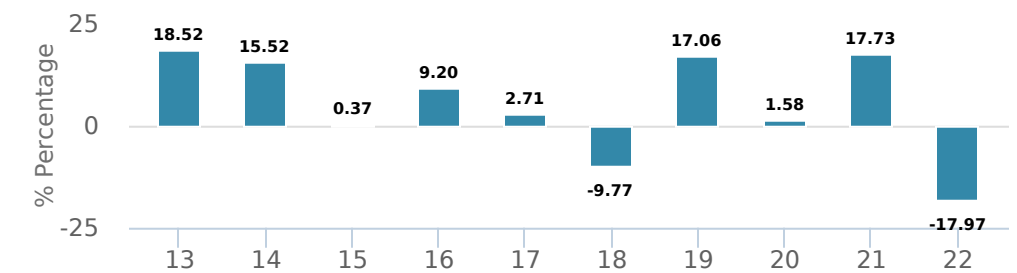
