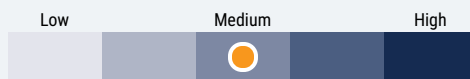
FUND OVERVIEW

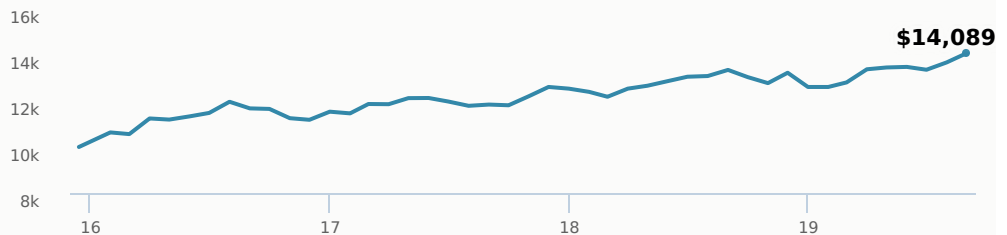
