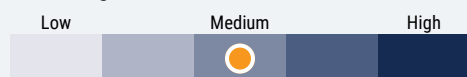
FUND OVERVIEW

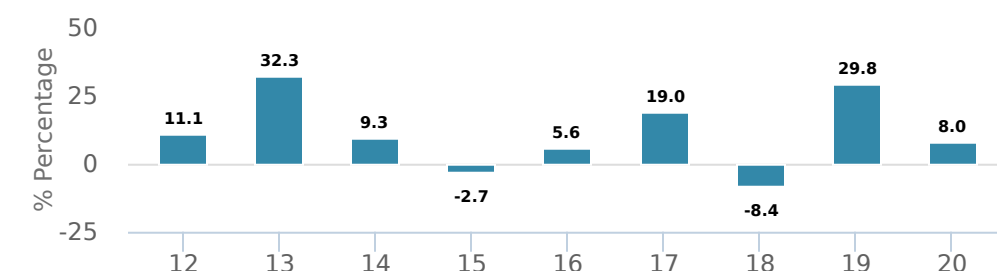
