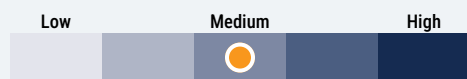
FUND OVERVIEW

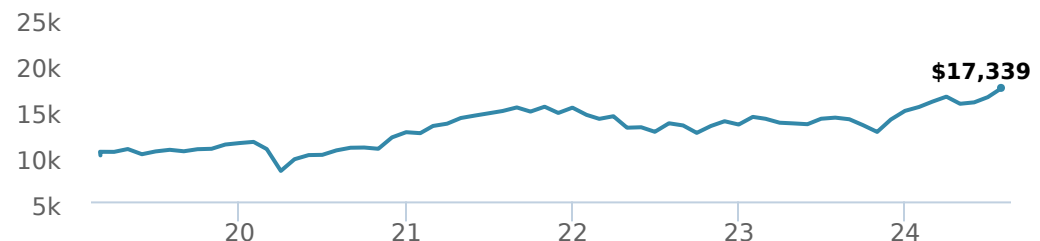

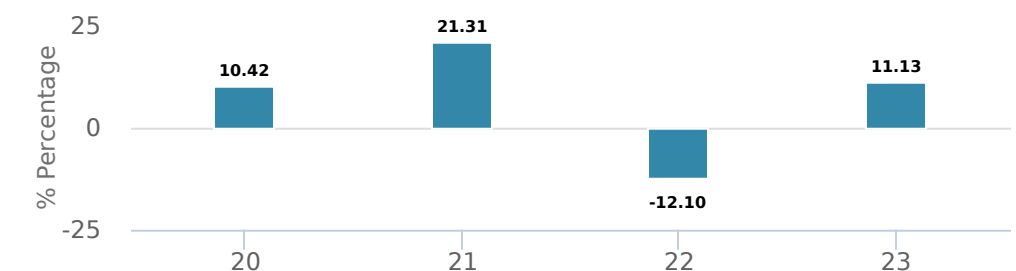

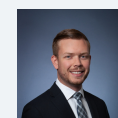
