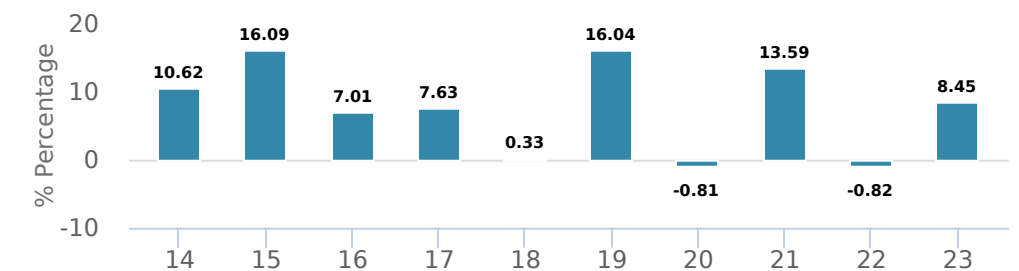

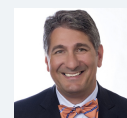
## MANAGEMENT TEAM
