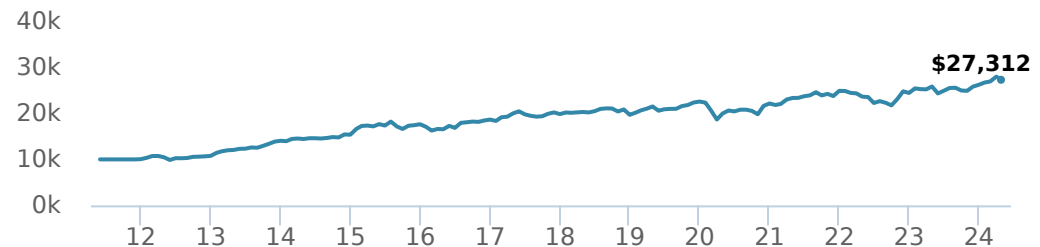

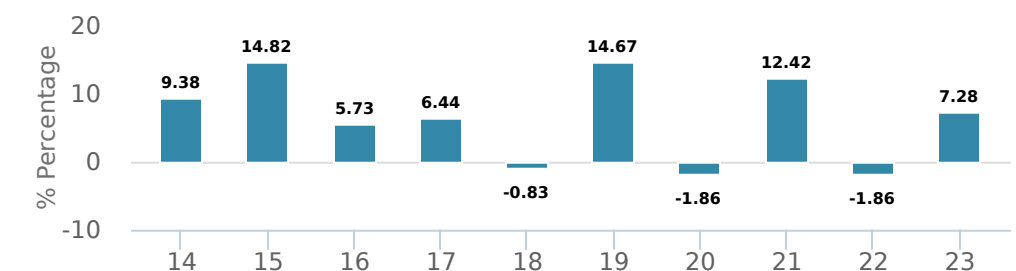

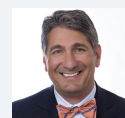
MANAGEMENT TEAM
