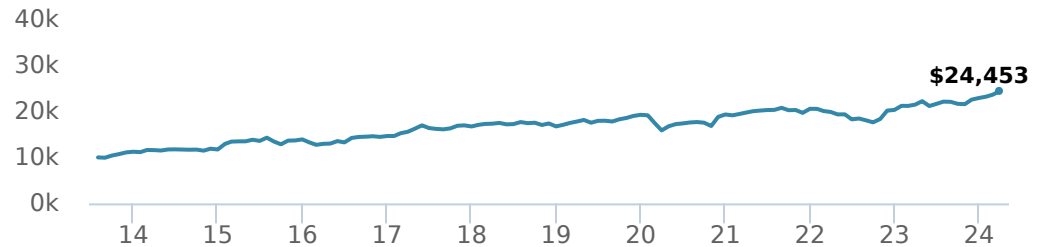

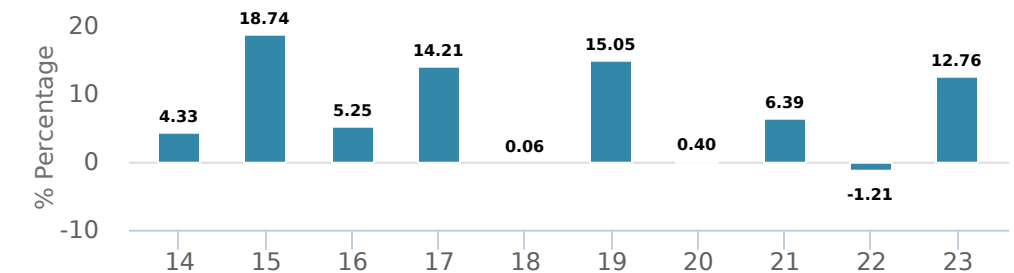

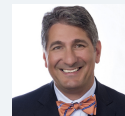
MANAGEMENT TEAM
