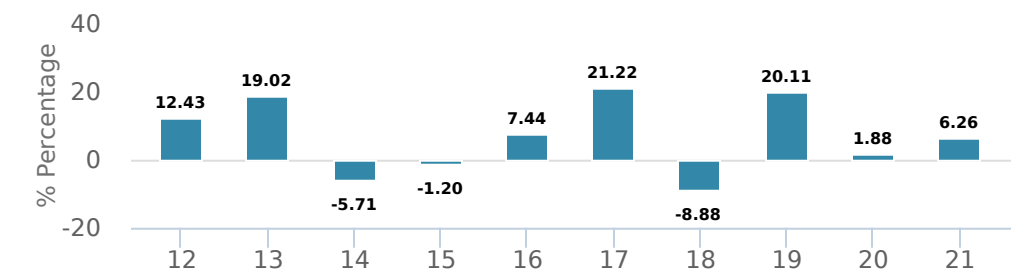

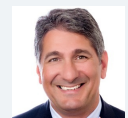
MANAGEMENT TEAM
