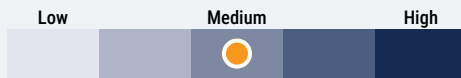

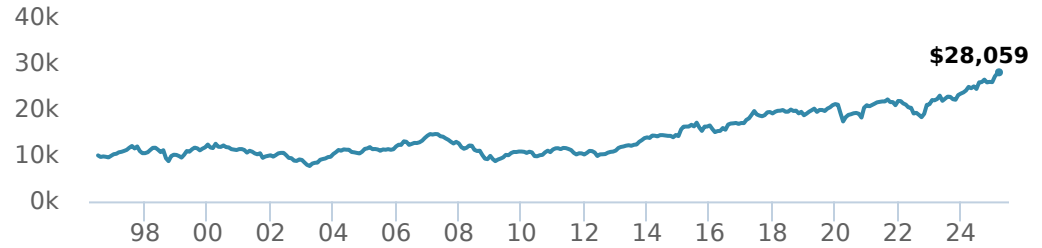

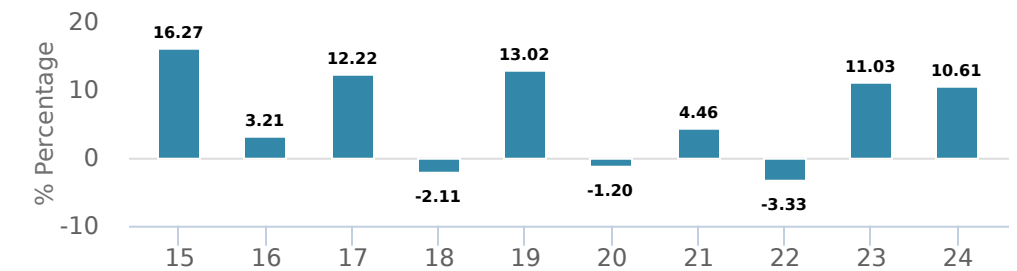

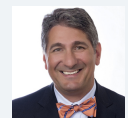
MANAGEMENT TEAM
