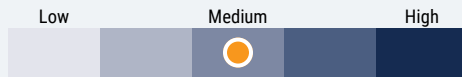
FUND OVERVIEW

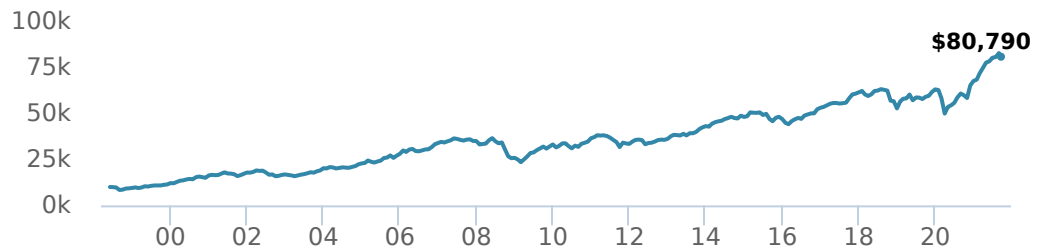

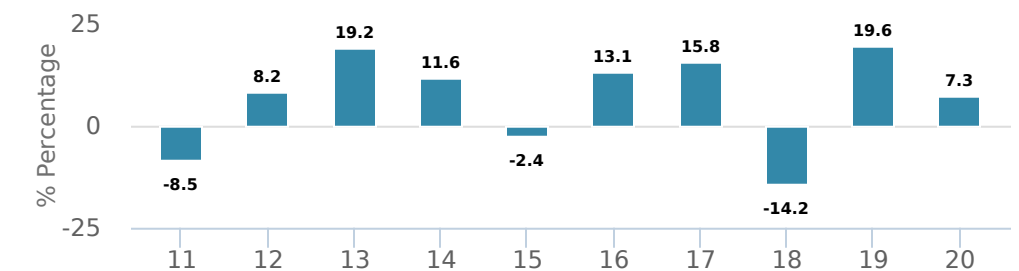
