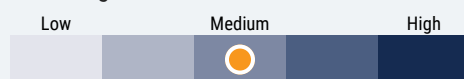
FUND OVERVIEW

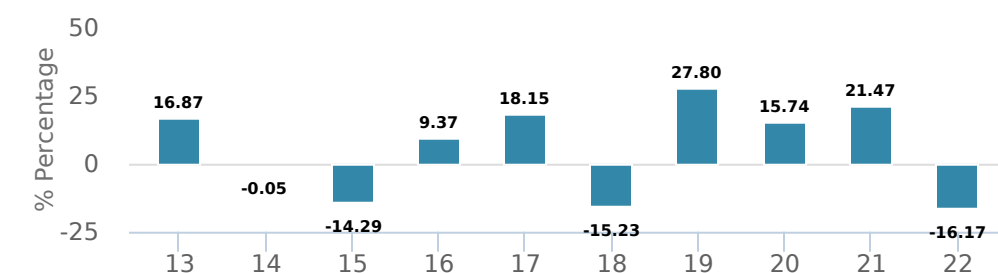
