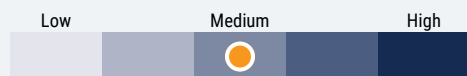
FUND OVERVIEW

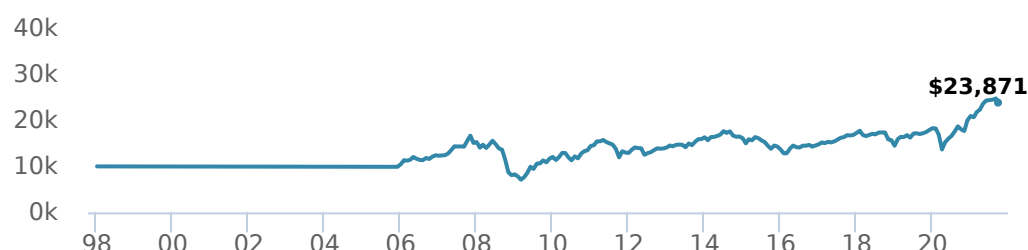

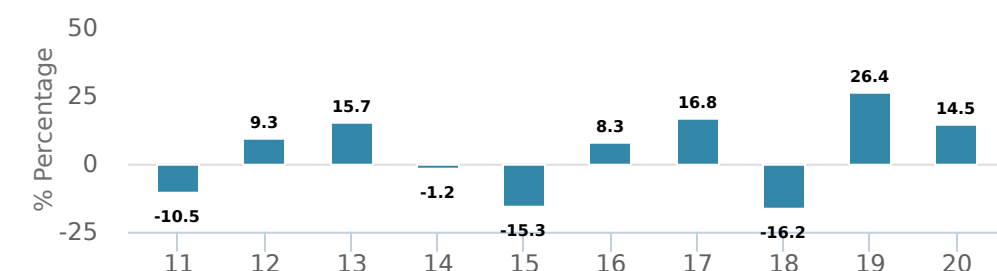
