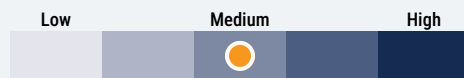
## FUND OVERVIEW

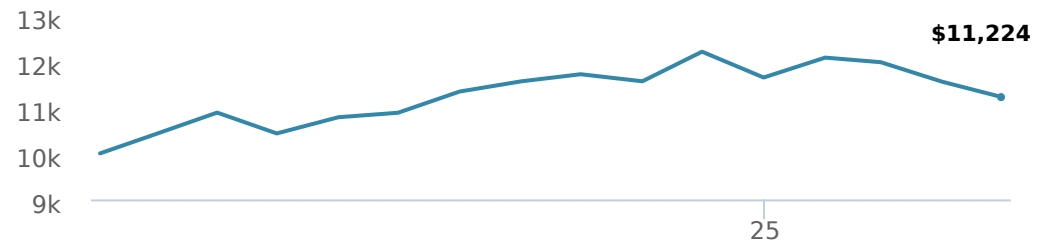
