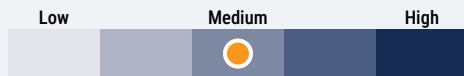
## FUND OVERVIEW

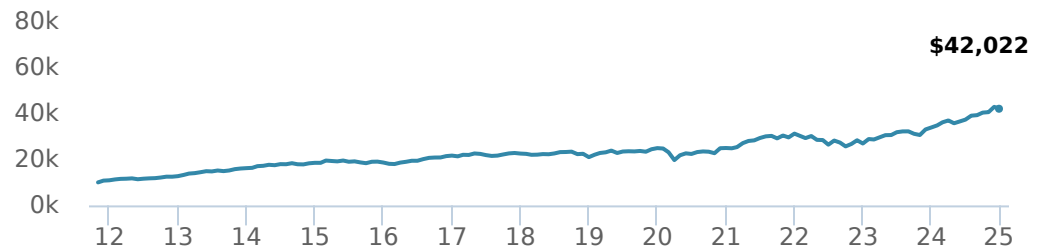

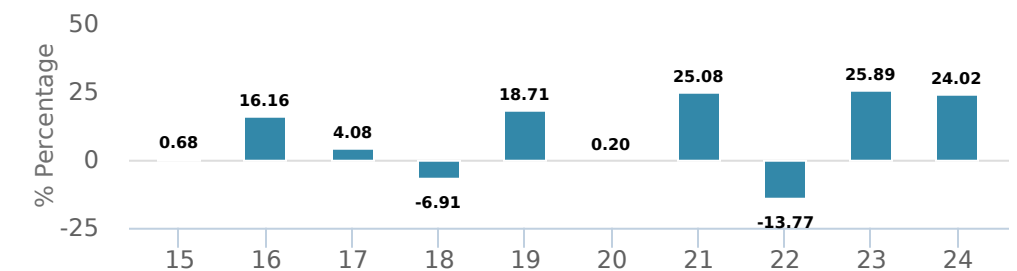

### Average annual compound returns

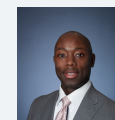
