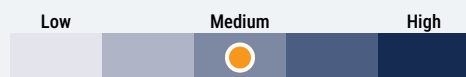





Average annual compound returns




