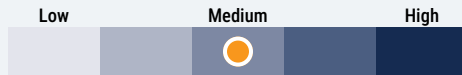

## Risk rating<sup>1</sup>



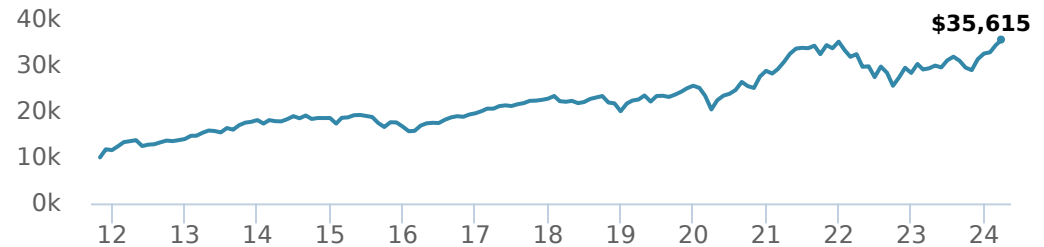

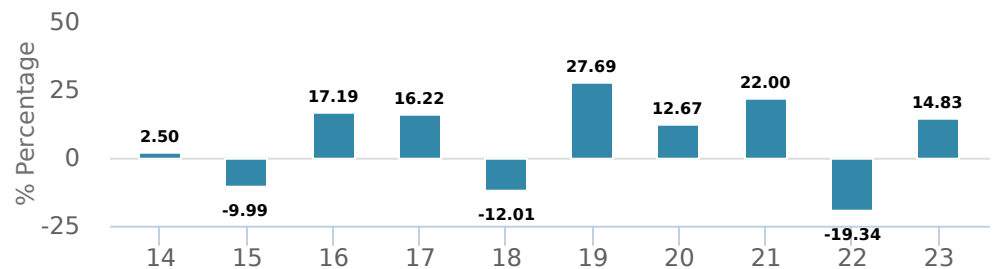

## Average annual compound returns

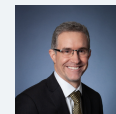
