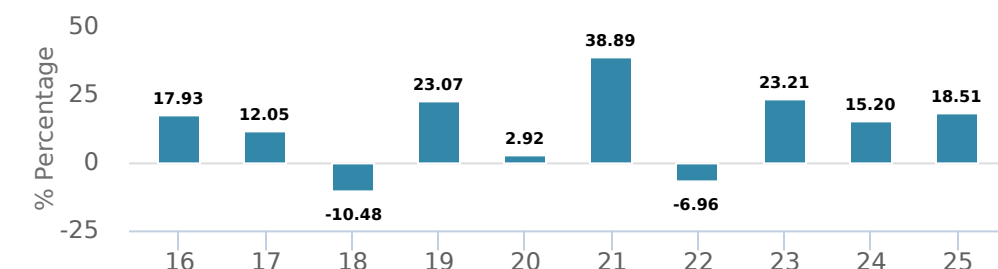

Calendar year performance

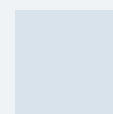
