To reduce the impact of exchange-rate fluctuations, derivatives are used to passively hedge approximately half of the Fund's foreign-currency exposure.

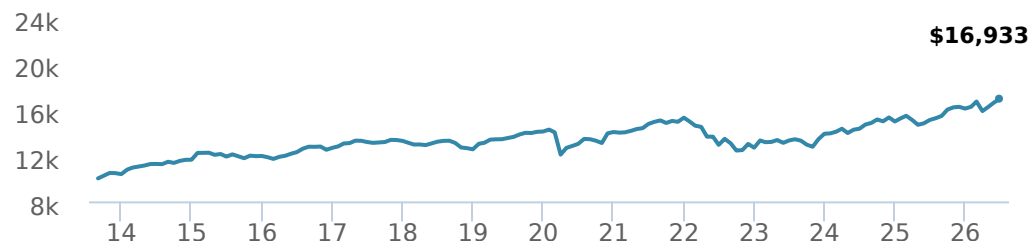

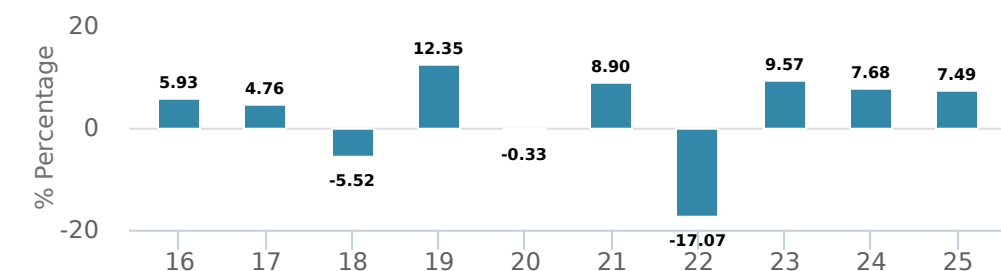

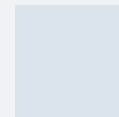
