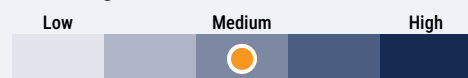
FUND OVERVIEW

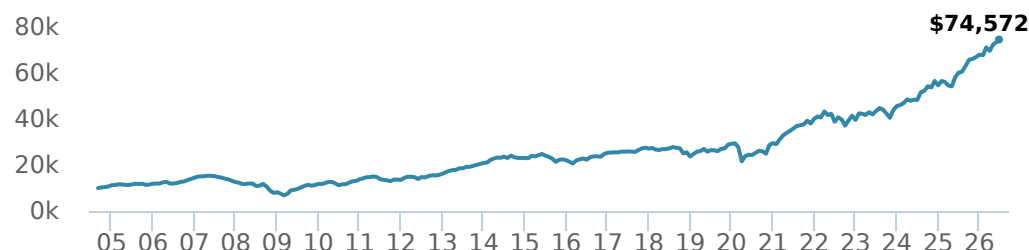

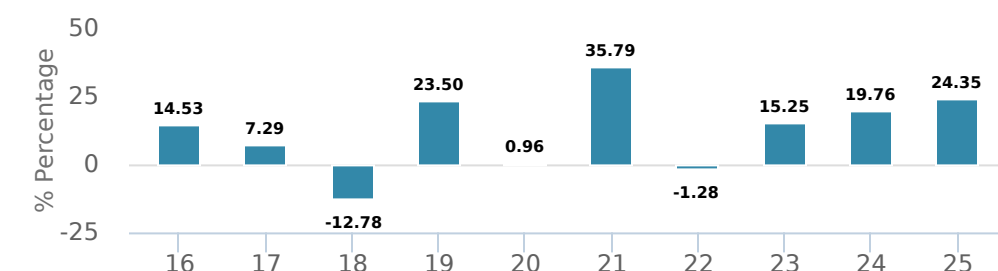
