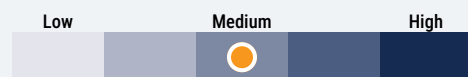
FUND OVERVIEW

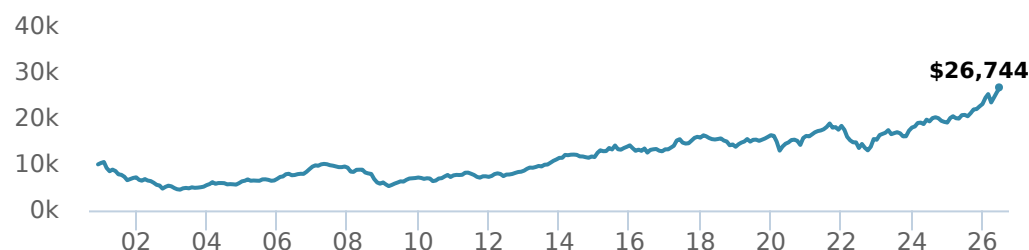

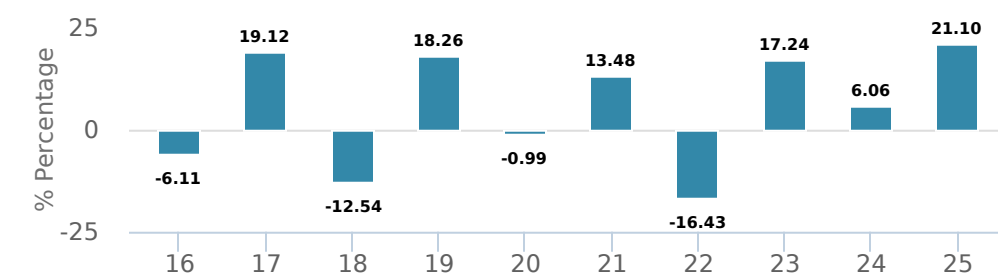

Calendar year performance



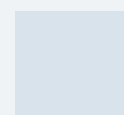

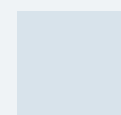

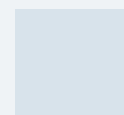
