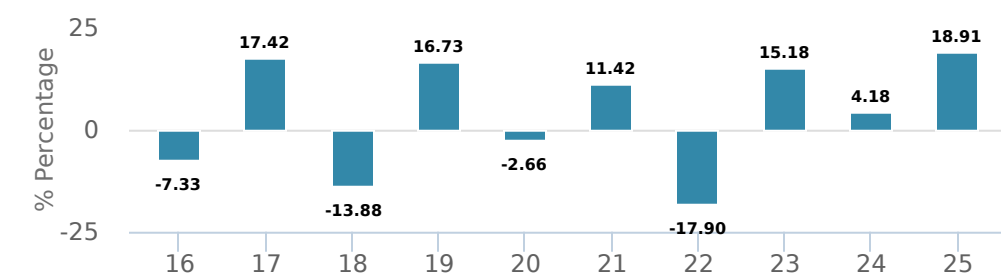

Calendar year performance



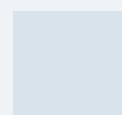

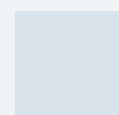

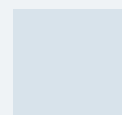
