## Risk rating<sup>1</sup>



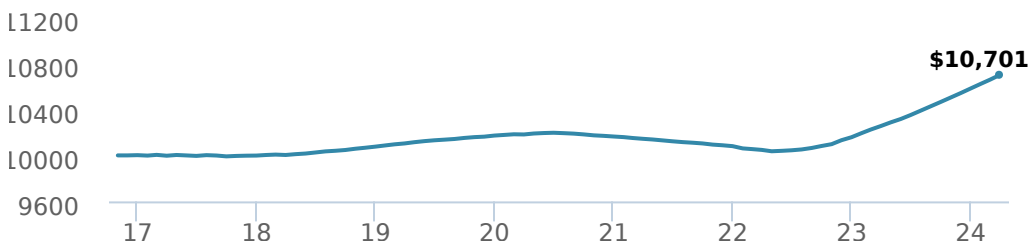

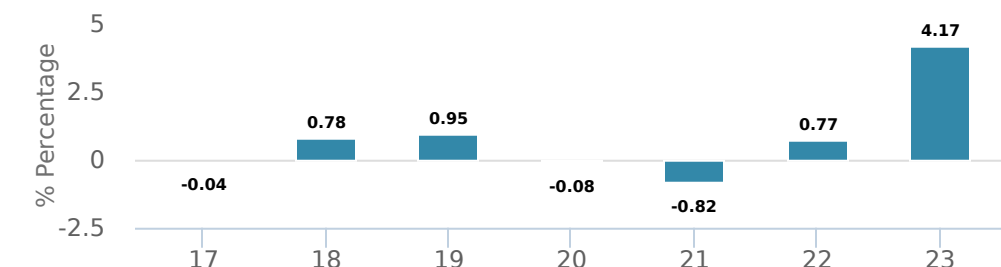

Average annual compound returns

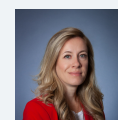

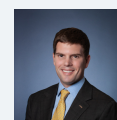
