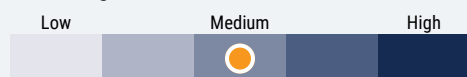
FUND OVERVIEW

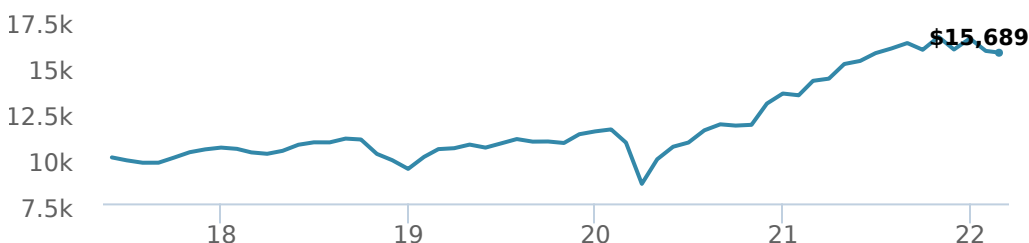

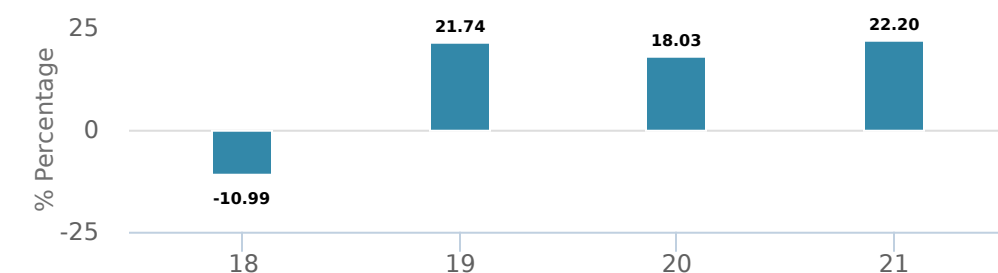
