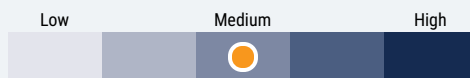
FUND OVERVIEW

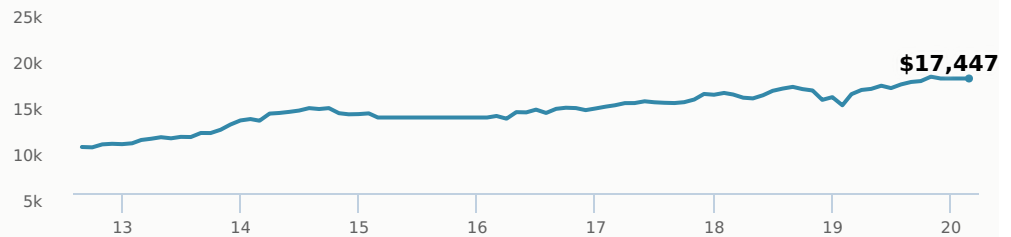

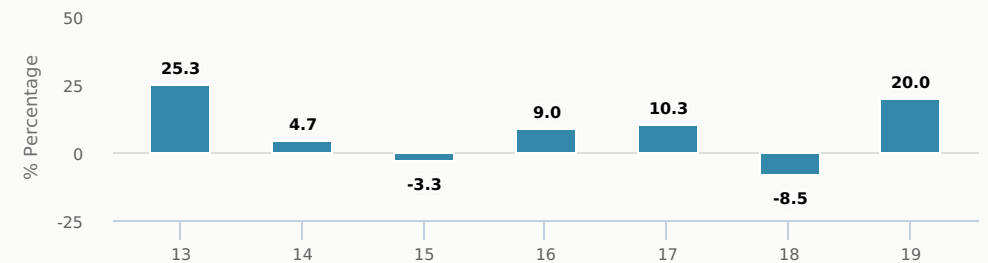
