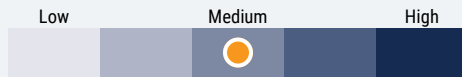

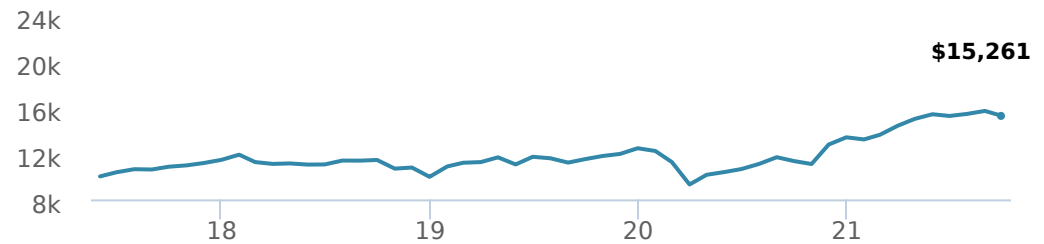

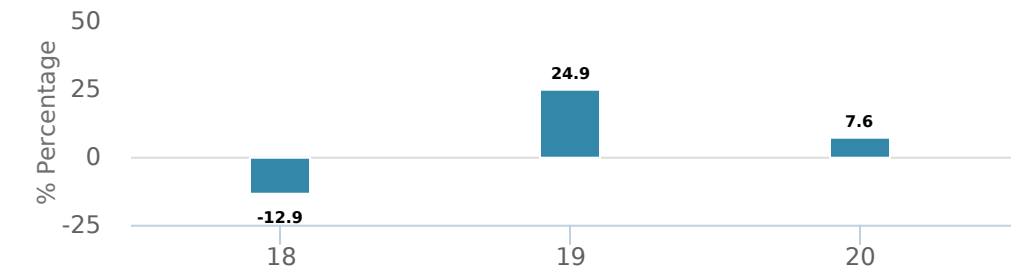

Average annual compound returns

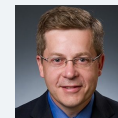
