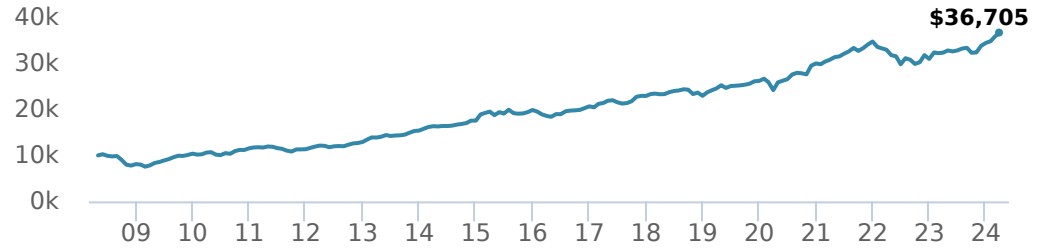

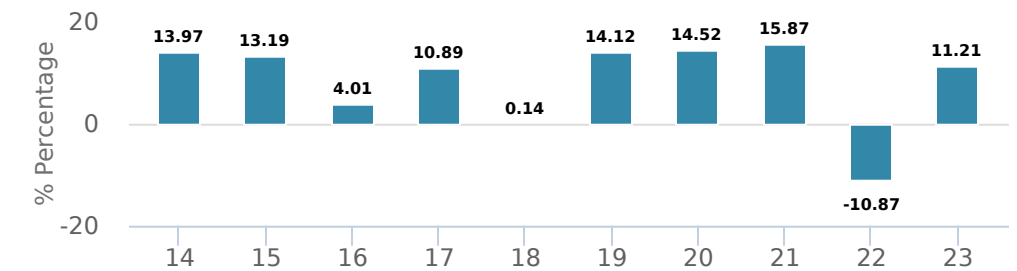

Average annual compound returns

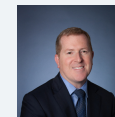

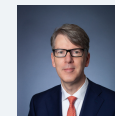

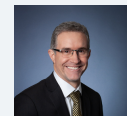
