The AIS contains information that will enable you, if you choose, to treat the mutual fund as a Qualified Electing Fund ("QEF") for U.S. federal income tax purposes.

Canadian mutual funds are generally considered PFICs under U.S. tax rules. We recommend that dients who do not file U.S. federal income tax returns on a cash basis consult their U.S. tax advisors regarding the appropriate U.S. dollar conversion rate.
