The AIS contains information that will enable you, if you choose, to treat the mutual fund as a Qualified Electing Fund ("QEF") for U.S. federal income tax purposes.

Canadian mutual funds are generally considered PFICs under U.S. tax rules. Please be aware that cash and property distributions reported on the AIS are converted into U.S. dollars based on the U.S. Federal Reserve spot rate in effect on the date the distribution is paid. We recommend that clients who do not file U.S. federal income tax returns on a cash basis consult their U.S. tax advisors regarding the appropriate U.S. dollar conversion rate.

Note that the information attached with this letter is intended to help you make one or more QEF elections, if you decide todo so, and neither such information nor this letter constitutes tax advice. Taxpayers should seek advice based on their particular circumstances from an independent U.S. tax advisor.
