Please find enclosed a Passive Foreign Investment Company ("PFIC") Annual Information Statement ("AIS") for the requested mutual fund. The AIS contains information that will enable you, if you choose, to treat the mutual fund as a Qualified Electing Fund ("QEF") for U.S. federal income tax purposes.

Canadian mutual funds are generally considered PFICs under U.S. tax rules. We recommend that all U.S. taxpayer clients consult with their U.S. tax advisors concerning the overall tax consequences of their ownership of mutual funds and their U.S. tax reporting requirements. You can also find information on U.S. tax rules applicable to investments in PFICs and on completing Form 8621 *"Information Return by a Shareholder of a Passive Foreign Investment Company or QualifiedElecting Fund"* at http://www.irs.gov/pub/irs-pdf/i8621.pdf.

If you hold a Class Fund (or Fund of Funds) that holds one or more underlying mutual funds, you will receive a CombinedAIS containing information that will enable you to elect to treat the Class Fund (or Fund of Funds) and any or all of theunderlying mutual funds as a QEF as you choose, as well as the tax information relating to the underlying mutual funds.

Please be aware that cash and property distributions reported on the AIS are converted into U.S. dollars based on the U.S. Federal Reserve spot rate in effect on the date the distribution is paid. We recommend that clients who do not file U.S. federal income tax returns on a cash basis consult their U.S. tax advisors regarding the appropriate U.S. dollar conversion rate.

Note that the information attached with this letter is intended to help you make one or more QEF elections, if you decide to do so, and neither such information nor this letter constitutes tax advice. Taxpayers should seek advice based on their particular circumstances from an independent U.S. tax advisor.
