Its Head Office address is 150 King Street West, Toronto, Ontario. It was formed by the amalgamation on December 31, 2002 of Sun Life Assurance Company of Canada and Clarica Life Insurance Company, which were originally incorporated in 1865 and 1878 respectively. The Clarica name will still be used to identify the Funds described in this Information Folder and the agents responsible for distributing and servicing Clarica Portfolio investments.

About CI Mutual Funds Inc.

CI Mutual Funds Inc. is a Canadian-owned investment management company. It is a wholly-owned subsidiary of CI Fund Management Inc., a publicly traded company listed on the Toronto Stock Exchange. CI Mutual Funds Inc. has been appointed by Sun Life Assurance Company of Canada to perform certain administrative and management services on its behalf in relation to the segregated funds and the individual variable insurance contract described in this Information Folder. In this Information Folder, references to CI are to CI Mutual Funds Inc. acting on behalf of Sun Life Assurance Company of Canada, unless indicated otherwise.

References to actions to be taken by "Sun Life" or "Sun Life Assurance Company of Canada" mean that the action will be taken or service provided exclusively by Sun Life Assurance Company of Canada.

Executive summary

- The Clarica Portfolio is an individual variable insurance contract issued by Sun Life Assurance Company of Canada. The contract is individual because it insures the life of an individual, called the insured person or annuitant. It's variable because the value of your segregated fund investments can vary or fluctuate.
- When you purchase Clarica Portfolio, you're buying an insurance contract. Your contributions can be invested in a variety of segregated funds. A segregated fund invests in units of an underlying mutual fund. For more information, see Types of investments available in your Clarica Portfolio on page 3.
- The Clarica Portfolio segregated funds have two types of guarantees provided by Sun Life Assurance Company of Canada

 a maturity guarantee and a death benefit guarantee. The maturity guarantee is the minimum amount that your segregated funds will be worth on or after a contribution maturity date. The death benefit guarantee is the minimum amount that your segregated funds will be worth on the death of the insured person.
 For more information, see Guarantees provided by your segregated funds on page 4.
- There are two different classes of units for the segregated funds: no-load class and DSC class A. Each class of each segregated fund has a different unit price except for the Clarica SF CI Canadian Conservative Portfolio, Clarica SF CI Canadian Income Portfolio, Clarica SF CI Canadian Balanced Portfolio, Clarica SF CI Global Balanced Portfolio, Clarica SF CI Global Conservative Portfolio, Clarica SF CI Global Fund, Clarica SF CI Global Growth Portfolio, Clarica SF CI Global Maximum Growth Portfolio, Clarica SF CI International Balanced Fund, Clarica SF CI Synergy American Momentum Fund and Clarica SF CI Money Market Fund. The unit price is the price at which units of segregated funds are bought, sold and exchanged. The unit price of a segregated fund is not guaranteed and may fluctuate with the market value of the underlying assets of that segregated fund. If you invest in segregated funds, you do not have any direct claim on the assets of the segregated funds and you're not a unitholder of the underlying mutual funds. For more information, see Segregated funds on page 3.
- There are management fees and other expenses for both the segregated funds and the underlying mutual funds. However, these fees are not duplicated. For more information, see Fees and expenses paid by the segregated fund on page 13.
- You can make withdrawals from your Clarica Portfolio at any time unless your Clarica Portfolio is a Locked-In Registered Retirement Savings Plan (RRSP) or a Locked-In Retirement Account (LIRA), in which event your withdrawals are restricted under applicable provincial pension rules. There may be fees that apply when you make withdrawals. For more information, see Fees and expenses paid directly by you on page 14. Making a withdrawal may also have income tax consequences. For more information, see Your income tax considerations on page 16.
- If you have a registered Clarica Portfolio you're always the insured person. Registered Clarica Portfolios include Registered Retirement Savings Plans (RRSPs), Locked-in RRSPs, Locked-In Retirement Accounts (LIRAs), Registered Retirement Income Funds (RRIFs), Life Income Funds (LIFs) and Locked-in Retirement Income Funds (LRIFs). If you have a non-registered Clarica Portfolio, someone other than you may be the insured person.
- Depending on the type of Clarica Portfolio you have, there is normally a date after which you may no longer own the Clarica Portfolio.

Non-registered Clarica Portfolios may be held until December 31 of the year the insured person turns 100 years old. At age 100 you must transfer a non-registered Clarica Portfolio to a payout annuity.

Registered Retirement Savings Plans (RRSPs), Locked-in RRSPs and Locked-In Retirement Accounts (LIRAs) may be held until December 31 of the year you turn 69 years old. At age 69 you must transfer an RRSP to a RRIF or a payout annuity. For a Locked-in RRSP or a LIRA, you must transfer to an LIF, an LRIF or a payout annuity.

Life Income Funds (LIFs) in all provinces except Quebec, Nova Scotia and New Brunswick may be held until December 31 of the year you turn 80 years old.

There is no limit to how long you may hold Registered Retirement Income Funds (RRIFs), Locked-in Retirement Income Funds (LRIFs) and, in Quebec, Nova Scotia and New Brunswick, Life Income Funds (LIFs).

- You should review the Financial Highlights, starting at page 67, and the audited annual financial statements which accompany this Information Folder. The most recently filed audited financial statements are considered part of this Information Folder. We'll send you annual audited financial statements within four months of the end of every year.
- Semi-annual audited financial statements are also available upon request if received by October 31 of any year. For more information, see Correspondence from us on page 18.
- We reserve the right to change underlying mutual funds. If such a change is a Fundamental Change, you will have the rights described under "Fundamental Changes". Changing an underlying mutual fund to another substantially similar underlying mutual fund will not constitute a Fundamental Change provided immediately following the change the total management and insurance fee of the segregated fund is the same as, or lower than, its total management and insurance fee immediately before the change. A substantially similar underlying mutual fund is one that has a comparable fundamental investment objective, is in the same investment fund category and has the same or lower management fee as the underlying fund it replaces. If we change an underlying mutual fund of a segregated fund in which you hold units to a substantially similar underlying mutual fund, we will: (a) notify you, our regulators and the Canadian Life and Health Insurance Association Inc. at least 60 days in advance of the change (unless such notice is not practical in the circumstances, in which event we will provide notice as soon as reasonably practical), and (b) amend or refile this Information Folder to reflect the change. Changing an underlying mutual fund may result in a gain (or loss) being realized and allocated to you. The foregoing may be superceded by any regulatory developments governing changes to underlying funds.

Segregated funds should be part of a long-term investment strategy because the value of your investments can fluctuate over the short-term. As a result, we are required to tell you the following:

A description of the key features of the individual variable insurance contract is contained in this Information Folder. Subject to any applicable death and maturity guarantees, any part of a contribution or other amount that is allocated to a segregated fund is invested at the risk of the owner and may increase or decrease in value according to the fluctuations in the market value of the assets of the segregated fund.

Types of investments available in your Clarica Portfolio

When you make contributions to the Clarica Portfolio, you can invest in a variety of segregated funds.

Segregated funds

What is a segregated fund?

Segregated funds allow investors who have similar investment needs and goals to combine their money in a diversified portfolio. The segregated fund invests in an underlying mutual fund. As a unitholder of the segregated fund, you're not a unitholder of the underlying mutual fund. The mutual fund, in turn, invests in a variety of other investments, making up the diversified portfolio. This diversified portfolio is managed by a professional portfolio advisor. Generally, if the value of the units of the underlying fund goes up, the value of the segregated fund units goes up. Likewise, if the value of the units of the underlying fund units goes down, the value of the segregated fund units goes down.

When you invest in a segregated fund you do not have a direct claim on the units of the underlying mutual fund or any of the assets of the segregated fund, instead you've a contractual right to a benefit based on a portion of the assets held by the segregated fund. This contractual right is measured in units of the segregated fund. When you buy or sell units of the fund you're buying or selling the contractual rights of the fund. Each unit represents a portion of the value of all the investments of that specific segregated fund. Segregated funds do not distribute income, or capital gains or losses to investors. Instead, net income plus any net capital gains on the investments of the underlying fund are allocated to you. This allocation of income does not reduce the unit value of the segregated fund. For more information, see *Your income tax considerations* starting on page 16.

You pay fees, expenses and sales charges when you invest in segregated funds. These vary based on:

- the specific segregated fund you've invested in
- the number of units held in your contract
- the class of units held in your contract.

About Clarica Portfolio segregated funds

There are two different classes of units, each with a different sales charge option. For more information, see *Sales charges for segregated funds* on page 14.

Both classes of a segregated fund are managed together, as one pool of assets. However, each class has its own unit price. Each segregated fund is open-ended, which means that each segregated fund can issue an unlimited number of units.

Each segregated fund is described in detail in the section Specific information about the segregated funds described in this Information Folder starting on page 23. In this section we explain the investment objectives and strategies of the underlying funds. These may change, but we'll let you know 60 days in advance if they do. If any such change is a Fundamental Change we will follow the procedures and give you the rights described under Fundamental Changes on page 15. If a change to the investment objectives of an underlying fund is approved by the unitholders of that underlying fund, we will give you notice of that change and approval. In certain circumstances and at our discretion, we may give you our right to vote on changing the investment objectives of the underlying funds.

The underlying funds must comply with standard investment practices set out by securities laws. There is important information about each underlying mutual fund in that mutual fund's simplified prospectus. These simplified prospectuses can be downloaded from www.sedar.com. You can also ask for a simplified prospectus by calling CI Client Services at the number on the back cover of this Information Folder.

The Clarica Portfolio segregated funds have been established under the authority of section 451 of the Insurance Companies Act of Canada. The segregated funds comply with the Canadian Life and Health Insurance Association (CLHIA) guidelines and all applicable rules, regulations and laws for segregated funds.

We may discontinue, merge or partition any of the segregated funds available within the Clarica Portfolio. If we do, there will be no cost to you and we'll tell you in writing at least 60 days in advance. We'll tell you what we intend to do, what your choices are and when the change will be effective.

How we determine the unit price of a segregated fund

The unit price is the price at which units of segregated funds are bought, sold and exchanged. The unit price is the fund's net asset value divided by the number of units outstanding. There is a different unit price for each class of each segregated fund.

We determine the unit price for each class of each segregated fund in the Clarica Portfolio at the end of every business day.

To determine the unit price for each class, we calculate the net asset value of each class of the segregated fund by taking that class' proportionate share of assets less its liabilities. The unit price is the net asset value of that class of the segregated fund divided by the number of units outstanding for that class of the segregated fund.

To calculate the assets:

- we calculate the market value of the underlying fund by multiplying the number of units of the underlying fund that the segregated fund owns by the closing unit price of the underlying fund. If the closing unit price of the underlying fund is not available, we'll use the last available unit price
- then we add the market value of the underlying fund to any cash held by the segregated fund that hasn't yet been invested.

The liabilities are everything that class of the segregated fund owes, which includes operating expenses that it must pay.

The unit price of a segregated fund is not guaranteed and may fluctuate with the market value of the underlying assets of that segregated fund.

Guarantees provided by your segregated funds

The Clarica Portfolio segregated funds have two types of guarantees – a maturity guarantee and a death benefit guarantee. The maturity guarantee is the minimum amount that your segregated funds will be worth on or after a contribution maturity date. The death benefit guarantee is the minimum amount that your segregated funds will be worth on the death of the insured person while your Clarica Portfolio is in effect.

For more information, see Examples of how the segregated funds' guarantees work on page 6.

Dates that are important to your guarantees

Contribution set date

When you invest money in segregated funds, a *contribution set date* is established. The contribution set date for that money is always January 1 of the year you invested it. Everything you invest during one calendar year is pooled together and is given the same contribution set date. You will have a separate contribution set date for every year that you invest money in segregated funds.

Contribution maturity date

The contribution maturity date will be January 1 ten years after the contribution set date. For example, if you make a contribution during 2004 and do not reset your contribution set date, your contribution maturity date will be January 1, 2014.

If you've invested in segregated funds over several years, you may have several different contribution maturity dates.

Resetting your contribution set date

When your Clarica Portfolio has been in effect for one year, you may reset your contribution set date. Your new contribution set date will be January 1 of the year you reset. When you reset your contribution set date, you combine all your existing contribution set dates into one new contribution set date. As a result, the new contribution maturity date will be January 1 ten years after the new contribution set date.

If you reset your contribution set date before the contribution maturity date, you change the amount on which your guarantees are based to the market value of all your segregated funds on the date you reset.

If you reset your contribution set date on or after a contribution maturity date, you change the amount on which your guarantees are based to the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to all contribution set dates which have reached their contribution maturity date, adjusted for withdrawals and exchanges, plus 100% of the market value of the remainder of your segregated funds on the date you reset, or
- the market value of all your segregated funds on the date you reset.

You may reset your contribution set date once every calendar year by asking us in writing.

If you do not reset your contribution set date, it will **not** automatically reset on the contribution maturity date or on any other date. Your contribution maturity date will remain January 1 ten years after your contribution set date, even if you hold your investments for longer than ten years.

For non-registered plans, you cannot reset your contribution set date after December 31 of the year the insured person turns 69 years old, or if the insured person has died.

For RRSPs, Locked-in RRSPs and LIRAs, you can reset your contribution set date as long as you own your plan. However, if you reset your contribution set date after December 31 of the year you turn 59 years old, the reset is only valid if you transfer to a Clarica Portfolio

RRIF, LIF or LRIF and carry over the contribution maturity date. If you reset your contribution set date after December 31 of the year you turn 59, but transfer to a plan that is not a Clarica Portfolio, we'll revert to the previous contribution set date.

For RRIFs, LIFs, and LRIFs, you cannot reset your contribution set date after December 31 of the year you turn 69 years old.

Contributions made during the last 10 years of a plan

Any contributions that you make during the last 10 years that you may own a Clarica Portfolio have contribution maturity dates of the last day you may own your plan.

Therefore, for a non-registered Clarica Portfolio, any contributions you make after December 31 of the year the insured person turns 90 will have a contribution maturity date of December 31 of the year the insured person turns 100.

For RRSPs, Locked-in RRSPs and LIRAs, any contributions you make after December 31 of the year you turn 59 will have a contribution maturity date of December 31 of the year you turn 69, unless you transfer to a Clarica Portfolio RRIF, LIF or LRIF. For more information, see Transferring from an RRSP, Locked-in RRSP or LIRA Clarica Portfolio to a RRIF, LIF or LRIF Clarica Portfolio on page 11.

For LIFs in all provinces except Quebec, Nova Scotia and New Brunswick, any transfers you make after December 31 of the year you turn 70 will have a contribution maturity date of December 31 of the year you turn 80.

There is no limit to how long you may hold RRIFs, LRIFs and, in Quebec, Nova Scotia and New Brunswick, LIFs, as long as there is money in your Clarica Portfolio.

The segregated funds' maturity guarantee

On or after a contribution maturity date, your guaranteed minimum value is the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to that contribution set date, adjusted for withdrawals and exchanges, or
- the market value, at the time you exercise your guarantee, of the portion of your segregated funds attributed to that contribution set data.

The segregated funds' death benefit guarantee

If the insured person dies, Sun Life will pay a death benefit to the beneficiary you've named. We must receive proof that the insured person died while your Clarica Portfolio was in effect and you must give us any other information we need to pay the death benefit.

For a non-registered Clarica Portfolio, if the insured person dies before they are 69 years old, Sun Life will pay a death benefit that is the greater of:

- 100% of your contributions (including any growth locked-in by virtue of prior resets), adjusted for withdrawals and exchanges, or
- the market value of your segregated funds on the date we receive notification of the insured person's death together with all the required documentation.

For a non-registered Clarica Portfolio, if the insured person dies when they are 69 or older, Sun Life will pay a death benefit that is the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets), adjusted for withdrawals and exchanges, or
- the market value of your segregated funds on the date we receive notification of the insured person's death together with all the required documentation.

Guarantees provided by your segregated funds (continued)

For Registered Retirement Savings Plans (RRSPs), Locked-in RRSPs and Locked-In Retirement Accounts (LIRAs), Sun Life will pay a death benefit that is the greater of:

- 100% of your contributions (including any growth locked-in by virtue of prior resets), adjusted for withdrawals and exchanges, or
- the market value of your segregated funds on the date we receive notification of the insured person's death together with all the required documentation.

For Registered Retirement Income Funds (RRIFs), Locked-in Retirement Income Funds (LRIFs) and, Life Income Funds (LIFs), Sun Life will pay a death benefit that is the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets), adjusted for withdrawals and exchanges, or
- the market value of your segregated funds on the date we receive notification of the insured person's death together with all the required documentation.

If your spouse is named as the beneficiary of your RRIF, instead of a lump sum payment, they can choose to continue to receive the periodic income payments you established. If they do, the maturity guarantees will remain in place.

How withdrawals affect your guarantees

If you make a withdrawal from your segregated funds, it will affect your guarantees.

This is how we calculate the effect on your guarantee:

- first, we take 75% of your contributions (including any growth locked-in by virtue of prior resets), adjusted for any previous withdrawals or exchanges,
- then we multiply this amount by the amount of your withdrawal divided by the total market value of all your segregated funds on the day you make the withdrawal.

This gives us the amount by which your guarantees will be reduced.

We apply this reduction to the value of your segregated funds attributed to your earliest contribution set date. Then, as necessary, we'll reduce the value of your segregated funds attributed to later contribution set dates on a first in first out basis.

Examples of how the segregated funds' guarantees work

When the market value is greater than the guaranteed value on the contribution maturity date

Let's assume you made the following contributions to your Clarica Portfolio and bought units in segregated funds:

•	January 3, 2004\$1,000
•	March 7, 2004\$2,000
•	December 1, 2004\$3,000

We'll also assume that you made no withdrawals or exchanges.

The contribution set date for all these contributions is January 1, 2004
The value of your segregated funds units attributed to the contribution set date is\$6,000
The contribution maturity date is January 1, 2014

We'll assume that the market value on January 1, 2014 is \$11,900.

On your contribution maturity date you're guaranteed the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to that contribution set date, adjusted for withdrawals and exchanges (75% x \$6,000 = \$4,500), or
- the market value, at the time you exercise your guarantee, of the portion of your segregated funds units attributed to that contribution set date (\$11,900).

Therefore, on January 1, 2014, if you withdrew your money from your segregated funds, Sun Life would pay you \$11,900.

When the market value is less than the guaranteed value on the contribution maturity date

Let's assume you made the following contributions to your Clarica Portfolio and bought units in segregated funds:

January 3, 2004\$1,	.000
March 7, 2004\$2,	.000
December 1, 2004\$3,	.000

We'll also assume that you made no withdrawals or exchanges.

The contribution set date for all these contributions is
The value of your segregated funds units attributed to the contribution set date is \$6,000
The contribution maturity date isJanuary 1, 2014

We'll assume that the market value on January 1, 2014 is \$4,200.

On your contribution maturity date you're guaranteed the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to that contribution set date, adjusted for withdrawals and exchanges (75% x \$6,000 = \$4,500), or
- the market value, at the time you exercise your guarantee, of the portion of your segregated funds units attributed to that contribution set date (\$4,200).

Therefore, on January 1, 2014, if you withdrew your money from your segregated funds, Sun Life would pay you \$4,500.

When you reset your contribution set date before the contribution maturity date

Let's assume you made the following contributions to your Clarica Portfolio and bought units in segregated funds:

•	January 3, 2004	 \$1,000
•	October 9, 2004	 \$2,000

We'll also assume that you made no withdrawals, exchanges or additional contributions.

The contribution set date for both these contributions is
The value of your segregated funds units attributed to the contribution set date is\$3,000
The contribution maturity date isJanuary 1, 2014

Now let's assume that on August 10, 2006 you decide to reset your contribution set date. We'll assume that the market value on August 10, 2006 is \$4,000.

Your new contribution set date isJanuary 1, 2006
Since you're resetting your contribution set date before the contribution maturity
date, the value of your segregated
funds units attributed to the new contribution
set date is the market value
of all your segregated funds,

Your new contribution maturity date is January 1, 2016

When you reset your contribution set date after the contribution maturity date

Let's assume that on August 10, 2004 you contributed \$4,000 to your Clarica Portfolio and bought units in segregated funds.

Your contribution set date isJanuary 1, 2004
The value of your segregated funds units attributed to this contribution set date is \dots
Your contribution maturity date isJanuary 1, 2014

We'll assume that you made no withdrawals, exchanges or additional contributions.

Now let's assume that on February 1, 2015 you decided to reset your contribution set date. We'll assume that the market value on February 1, 2015 is \$8,500.

Your new contribution set date isJanuary 1, 2015

Since you're resetting your contribution set date after the contribution maturity date, the value of your segregated funds units attributed to the new contribution set date is the greater of:

- 75% of your contributions attributed to all contribution set dates which have reached their contribution maturity date, or (75% x S4,000 = S3,000), or
- the market value of your segregated funds units on the date you reset (\$8,500).

Therefore, the value of your segregated funds units attributed to the new contribution set date is \$8,500.

Your new contribution maturity date is January 1, 2025

Examples of how the segregated funds' guarantees work (continued)

When you make withdrawals from your segregated funds

Let's assume you made the following contributions to your Clarica Portfolio and bought units in segregated funds:

Date of contribution	Amount of contribution	Contribution set date	Contribution maturity date
March 30, 2004	\$3,000	January 1, 2004	January 1, 2014
February 15, 2007	\$2,000	January 1, 2007	January 1, 2017

Let's also assume the following:

- on October 10, 2007 you withdrew \$1,000
- on October 10, 2007 the total market value of your segregated funds units is \$6,000
- you made no other withdrawals, exchanges or additional contributions.

We adjust the amount that we guarantee by reducing the guaranteed value of the earliest contribution set date first.

This is how we calculate the effect on your maturity guarantee:

- first, we calculate the value of your contributions, adjusted for previous withdrawals and exchanges,(\$3,000 + \$2,000 = \$5,000)
- then we multiply it by 75%(\$5,000 x 75% = \$3,750)
- then we multiply this amount
 by the amount of your withdrawal
 divided by the total market
 value of all your segregated
 funds units on the day you
 make the withdrawal (\$3,750 x \$1,000 ÷ \$6,000 = \$625).

This gives us the amount by which your maturity guarantee will be reduced.

We apply this reduction to 75% of the value of your segregated funds units attributed to your earliest contribution set date of January 1, 2004. [(\$3,000 x 75%) - \$625 = \$1,625]

After your withdrawal, this is how your maturity guarantee would be affected:

Contribution maturity date	75 % of the value of your segregated funds units attributed to the contribution set date, adjusted for withdrawals
January 1, 2014	\$1,625
January 1, 2017	\$1,500
	maturity date January 1, 2014

This is how we calculate the effect on your death benefit guarantee:

- first, we calculate the value of your contributions, adjusted for previous withdrawals and exchanges, (\$3,000 + \$2,000 = \$5,000)
- then we multiply this amount by the amount of your withdrawal divided by the total market value of all your segregated funds units on the day you make the withdrawal(\$5,000 x \$1,000 ÷ \$6,000 = \$833).

This gives us the amount by which your death benefit guarantee will be reduced.

We apply this reduction to the value of your segregated funds units attributed to your earliest contribution set date of January 1, 2004. (\$3,000 - \$833 = \$2,167)

After your withdrawal, this is how your death benefit guarantee would be affected:

Contribution set date	Contribution maturity date	Value of your segregated funds units attributed to the contribution set date, adjusted for withdrawals
January 1, 2004	January 1, 2014	\$2,167
January 1, 2007	January 1, 2017	\$2,000

When you receive periodic income payments from a RRIF

Let's make the following assumptions:

- you transferred \$20,000 from your RRSP to a new RRIF on May 1, 2004
- you chose not to carry over your contribution set dates from your RRSP. Instead you reset your contribution set date at the time of the transfer, so your contribution set date became January 1, 2004
- you receive monthly periodic income payments of \$750 starting June 1, 2004.

This is how we calculate the effect on your guarantee:

- first, we multiply the value of your contributions, adjusted for previous withdrawals and exchanges, by 75%
- then we multiply this amount by the amount of your withdrawal divided by the total market value of all your segregated funds units before the withdrawal on the day you make the withdrawal
- we subtract this amount from 75% of the value of your contributions, adjusted for previous withdrawals and exchanges.

The following table shows how six months of periodic income payments would affect your guarantee. In this example, we've also shown you the impact of declining market value.

Contributions, withdrawals and exchanges

How to make contributions to your Clarica Portfolio

You can make contributions to your Clarica Portfolio through your agent. You must pay us at the time you give your agent instructions as to how you would like your contribution invested.

Your agent then sends your instructions to CI. If CI receives your instructions on a business day before 4 p.m. we'll process them at the unit price determined at the close of business on that day. If CI receives your instructions after 4 p.m., we'll process them at the unit price determined at the close of business on the next business day.

If your payment comes back to CI because there are not sufficient funds (NSF) in your bank account, CI may charge you an NSF cheque charge of up to \$25. For more information, see Fees and expenses paid directly by you on page 14.

CI may reject your contribution within one business day of receiving it. If CI does, all your money will be refunded immediately without interest.

If you do not give CI clear instructions about your contribution, CI will reject your contribution.

When you buy units, the unit price of a segregated fund is not guaranteed and may fluctuate with the market value of the underlying assets of that segregated fund.

Lump sum contributions

You can make contributions to your Clarica Portfolio with a lump sum payment. However, you must invest a minimum amount. As described below, this amount varies according to the type of Clarica Portfolio you have and type of investment you make. We may change these minimum amounts at any time.

Non-registered plans, Registered Retirement Savings Plans (RRSPs), Locked-in RRSPs and Locked-In Retirement Accounts (LIRAs)
To open one of these plans, you must invest at least \$500. The \$500 can be divided among any number of segregated funds. You may make additional investments of at least \$50 for any segregated fund.

Registered Retirement Income Funds (RRIFs), Life Income Funds (LIFs) and Locked-in Retirement Income Funds (LRIFs)

To open one of these plans, you must invest at least \$5,000 in each plan. In addition, you can only invest in them with money transferred from another registered plan. The \$5,000 can be divided among any number of segregated funds. You may make additional transfers of at least \$50 for any segregated fund.

Pre-Authorized Chequing Plans

You can also make contributions to your Clarica Portfolio through a regular contribution plan, sometimes called a *Pre-Authorized Chequing Plan* or PAC. When you establish a regular contribution plan, you authorize CI to withdraw money from your bank account on a regular basis to make contributions to your Clarica Portfolio.

You can choose any day of the week or any day of the month to contribute and your bank account will be debited that day. If the day you choose falls on a day that is not a business day, your money will be invested the next business day.

There is no minimum amount you must have in your Clarica Portfolio when you make regular contributions. However, there are minimum amounts you must invest each time. If you invest every week or every two weeks, you must invest at least \$25 in a segregated fund. If you invest every month or every three months, you must invest at least \$50 in a segregated fund. We may change these minimum amounts at any time.

We do not send separate confirmation notices for each regular contribution you make. Instead, these transactions are reported on your annual and semi-annual statements.

You cannot set up a regular contribution plan for a RRIF.

How to make withdrawals from your Clarica Portfolio

You can withdraw money from most Clarica Portfolio plans at any time by sending a written request to your agent or directly to CI at the address on the back of this Information Folder. You may also give your agent instructions over the phone, by fax or by other electronic means. If you choose one of these methods, we must have a way of verifying your request.

In order to process your request, we must have all the information we need. This includes:

- your name and plan number
- the amount you want to withdraw
- how you would like to receive that money, for example, cheque or direct deposit to your bank account
- the name of the segregated fund from which you wish to sell units and the class of the units you wish to sell
- in certain circumstances, the signatures of all the owners of your Clarica Portfolio
- any legal documents, such as a power of attorney, that may be needed
- any other legal requirements there may be.

When you make a withdrawal, you must withdraw at least \$100. Also, when you withdraw money, it's important that the value of your Clarica Portfolio not fall below \$500. If your Clarica Portfolio falls below \$500, CI will tell you and give you 30 days to increase the total value of your Clarica Portfolio to at least \$500. If you do not increase it to \$500 within 30 days, CI may sell your investments, send you the proceeds, and close your Clarica Portfolio. When you withdraw money, if the value of all your investments falls to zero your Clarica Portfolio will be closed automatically.

Sun Life is the party responsible for all payments to you from your Clarica Portfolio. As part of its duties as manager, CI will process such payments on behalf of Sun Life.

CI will process your payment from a segregated fund at the unit price at the close of business on that day if CI receives your request on a business day before 4 p.m. Eastern standard time. If CI receives your request after 4 p.m., we will process it at the unit price at the close of business on the next business day.

When you sell units, the unit price of a segregated fund is not guaranteed and may fluctuate with the market value of the underlying assets of that segregated fund.

If you sell units of your segregated funds on or after a contribution maturity date, you will receive the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to that contribution set date, adjusted for withdrawals and exchanges, or
- the market value, at the time you sell your units, of the portion of your segregated funds attributed to that contribution set date.

For more information, see Guarantees provided by your segregated funds on page 4.

If your units are DSC class A units, you may have to pay a deferred sales charge when you sell your units. For more information, see *Sales charges for segregated funds* on page 14.

CI may temporarily suspend your right to sell units of your segregated funds if the units of the underlying funds are suspended. This will only happen if:

- normal trading is suspended on The Toronto Stock Exchange, the Montreal Exchange or any other exchange on which securities or derivatives that make up more than half of the underlying fund's total assets by value are traded, or
- the underlying fund manager has permission from the appropriate regulator.

Contributions, withdrawals and exchanges (continued)

If you've asked us to sell your segregated fund units when trading is suspended, we'll process your request on the first business day after the suspension at the unit price determined at the close of business on that day.

CI cannot accept requests to sell units of segregated funds at a future date or at a future price.

If you recently made a contribution to your Clarica Portfolio and you withdraw that same money, CI won't be able to give you the proceeds of your withdrawal until you've paid for your contribution and your cheque has cleared your bank account.

If your Clarica Portfolio is a Locked-in Registered Retirement Savings Plan (RRSP) or a Locked-In Retirement Account (LIRA), you cannot withdraw cash except as allowed under the applicable provincial pension rules. For more information, see Part D of the *RRSP* and *LIRA* contract on page 22.

CI will deposit the amount of your withdrawal directly into your bank account or, if you request, provide you with a cheque. For more information, see Fees and expenses paid directly by you on page 14.

When you make a withdrawal, you may be subject to certain fees and expenses. For more information about these fees, see *Fees and expenses paid directly by you* on page 14.

Making a withdrawal may have income tax consequences. For more information, see *Your income tax considerations* on page 16.

Periodic income payments from RRIFs, LIFs and LRIFs

If you've a Registered Retirement Income Fund (RRIF), Life Income Fund (LIF) or Locked-in Retirement Income Fund (LRIF), you must set up a regular withdrawal plan called a periodic income payment plan. By law, you must withdraw a minimum amount of money from a RRIF, LIF or LRIF on a regular basis, starting the year after you open it

There are four different payment options:

- 1. minimum payment amount the minimum amount you must withdraw is calculated by multiplying the total value of your Clarica Portfolio on January 1 each year, by a percentage determined by the Income Tax Act (Canada). For RRIFs, this percentage is based on your age or your spouse's age, depending on which you selected at the time you opened your Clarica Portfolio. For LIFs and LRIFs, this percentage is always based on your age. You can choose the date you receive your payment.
- maximum payment amount (LIF and LRIF only) the maximum amount you can withdraw is calculated according to the pension legislation governing your LIF or LRIF. You can choose the date you receive your payment.
- level payment amount you can choose the amount you want to receive before or after taxes, but each payment must be at least \$50. You can choose the date you receive your payment.
- 4. unscheduled payment amount there is no payment schedule established. You can tell us during the year if you would like a payment. If, by December 15, you've not withdrawn at least the minimum amount, CI will make a payment equal to the difference between the payments you've received and the minimum amount.

If, for any reason, the total payments made to you during a calendar year are less than the minimum amount you must receive that year, CI will make an additional payment to you before the end of the year.

You can choose to receive your periodic income payments monthly, quarterly, semi-annually or annually. You may change the frequency once every 12 months.

CI will deposit the proceeds from your periodic income payment directly into your bank account.

CI will make your periodic income payments by selling units of your segregated funds. If you've more than one fund and you do not specify which fund we should use, we'll sell units from each fund. The amount we withdraw from each fund will be based on the percentage of the total value of your RRIF, LIF or LRIF in each fund on the day the payment is made.

We'll process your periodic income payment at the unit price determined at the close of business on that day.

How to exchange investments within your Clarica Portfolio

You may exchange investments between segregated funds. To do so, you must send a written request to your agent, or directly to CI at the address on the back of this Information Folder. You may also give your agent instructions over the phone, by fax or by other electronic means. If you choose one of these methods, we must have a way of verifying your request.

When you exchange investments, you effectively withdraw your money from one investment and invest it in another. The procedures and minimum purchase amounts are exactly the same as those described in *How to make contributions to your Clarica Portfolio* and *How to make withdrawals from your Clarica Portfolio* on page 9.

You may only exchange no-load units of a segregated fund for no-load units of another fund. There are no sales charges when you exchange no-load units of a segregated fund.

You may only exchange DSC class A units of a segregated fund for DSC class A units of another fund. There are no sales charges when you exchange between segregated funds.

If you exchange units of one segregated fund for units of another segregated fund, it will not change the contribution maturity date. For more information, see *Guarantees provided by your segregated funds* on page 4.

When you exchange units, the unit price of a segregated fund is not guaranteed and may fluctuate with the market value of the underlying assets of that segregated fund.

If you exchange units of a segregated fund within 60 days of buying them, we may charge you a 60 day exchange fee. For more information, see Fees and expenses paid directly by you on page 14. We may also reject your request to exchange units of your segregated funds if, within 60 days of selling or exchanging units, you ask for an exchange back to units of the original fund. The exchange privilege is not meant for speculating on short-term movements in the markets. This can hurt a segregated fund's performance and negatively affect the remaining investors in the fund.

Exchanging investments in a non-registered Clarica Portfolio may have income tax consequences. For more information, see *Your income tax considerations* on page 16.

Automatic exchanges for segregated funds

You can set up automatic exchanges so that units of one segregated fund can regularly be exchanged for units of another segregated fund. Automatic exchanges can only be set up between funds with the same class of units.

We do not send separate confirmations for each automatic exchange. Instead, these transactions will be reported on your annual and semi-annual statements.

Optional services

Transferring from a non-registered Clarica Portfolio to an RRSP Clarica Portfolio

You may transfer all or part of a non-registered Clarica Portfolio to a Registered Retirement Savings Plan (RRSP) Clarica Portfolio at any time by contacting your agent.

If CI receives your instructions on a business day before 4 p.m. Eastern standard time, we'll process them at the close of business on that day. If we receive your instructions after 4 p.m., we'll process them at the close of business on the next business day.

For more information about investing in an RRSP, see *How to make contributions to your Clarica Portfolio* on page 9.

The following components of your non-registered Clarica Portfolio are carried over to your RRSP:

- the length of time you're considered to have owned your segregated funds units for the purpose of calculating deferred sales charges
- the contribution set dates for your segregated funds units, unless you tell us otherwise. For more information, see Resetting your contribution set date on page 4.

Transferring from a non-registered Clarica Portfolio to an RRSP Clarica Portfolio may have income tax consequences. For more information, see *Your income tax considerations* on page 16.

Transferring from an RRSP, Locked-in RRSP or LIRA Clarica Portfolio to a RRIF, LIF or LRIF Clarica Portfolio

You may transfer all or part of a Registered Retirement Savings Plan (RRSP), Locked-in RRSP or Locked-In Retirement Account (LIRA) Clarica Portfolio to a Registered Retirement Income Fund (RRIF), Life Income Fund (LIF) or Locked-in Retirement Income Fund (LRIF) Clarica Portfolio at any time. However, you cannot own an RRSP, Locked-in RRSP or LIRA after December 31 of the year you turn 69 years old. At that time, you must transfer your entire RRSP, Locked-in RRSP or LIRA to a RRIF, LIF, LRIF or payout annuity.

You can transfer from an RRSP, Locked-in RRSP or LIRA to a RRIF, LIF or LRIF by contacting your agent.

If CI receives your instructions on a business day before 4 p.m. Eastern standard time, we'll process them at the close of business on that day. If CI receives your instructions after 4 p.m., we'll process them at the close of business on the next business day.

For more information about investing in a RRIF, LIF or LRIF, see *How to make contributions to your Clarica Portfolio* on page 9.

The following components of your RRSP, Locked-in RRSP or LIRA are automatically carried over to your RRIF, LIF or LRIF:

- the length of time you're considered to have owned your segregated funds units for the purpose of calculating deferred sales charges
- the contribution set dates for your segregated funds units, unless you tell us otherwise. For more information, see Resetting your contribution set date on page 4.

When you transfer from an RRSP, Locked-in RRSP or LIRA to a RRIF, LIF or LRIF, the amount of your segregated funds death benefit guarantee will change to the greater of:

 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to all contribution set dates, adjusted for withdrawals and exchanges, or the market value of your segregated funds units on the date we receive notification of the insured person's death together with all the required documentation.

For more information about the guarantees, see *Guarantees provided* by your segregated funds on page 4.

Transferring to another financial institution

You may transfer all or a portion of your Clarica Portfolio to another financial institution at any time by sending a written request to your agent or directly to CI at the address on the back of this Information Folder.

CI will treat your transfer to another financial institution as if you were selling your investments. For more information, see *How to make withdrawals from your Clarica Portfolio* on page 9.

If you transfer to another financial institution within 60 days of making a contribution, you may have to pay a 60 day exchange fee. For more information, see *Fees and expenses paid directly by you* on page 14.

Making a transfer to another financial institution may have income tax consequences. For more information, see *Your income tax considerations* on page 16.

Cl's asset allocation process

Clarica agents may use the asset allocation process developed and managed by CI to help you develop an Investment Plan that meets your investment objectives. It's important that you review this Investment Plan on a regular basis to ensure it's up to date and is still consistent with your investment objectives.

You and your agent will discuss your investment objectives and your tolerance for risk to map out recommended percentages of your investments that should be in cash equivalents, fixed income securities, equities and foreign investments. A mix of investments that are available in the Clarica Portfolio will be suggested using these percentages. You may then select the types of investment and percentages suggested, or by making some adjustments to them, create your own model portfolio.

You can advise CI of your target fund allocation and CI will review your current fund allocation compared to your target fund allocation monthly, quarterly, semi-annually or annually. We review your account to determine if you're scheduled for a target fund allocation review and if so, if your investment in any fund varies by more than the percentage of variance you have selected for your target fund allocation, we will automatically switch your investments to return to your target fund allocation.

You may change your model portfolio or your option of how to rebalance the investments in your Clarica Portfolio at any time by meeting with your agent.

We may change the asset allocation process at any time.

You may only establish a model portfolio using funds with the same load type and the same class of units.

Rebalancing the investments in a non-registered Clarica Portfolio may have income tax consequences. For more information, see *Your income tax considerations* on page 16.

You do not have to use CI's asset allocation process to invest in a Clarica Portfolio.

Optional services (continued)

Foreign content rebalancing service

Currently, Canadian tax laws do not consider any of the investments available in the Clarica Portfolio to be foreign property. However, these laws may change at any time and some of the segregated funds may be considered foreign property. If that happens, there will be limits on the percentage of your registered Clarica Portfolio that can be considered foreign content. If the foreign content in your registered Clarica Portfolio is over that limit you may be charged a penalty tax.

If these laws come into effect, we'll make our foreign content rebalancing service available for your registered Clarica Portfolios. CI will provide this service so you don't have to pay the penalty tax. However, neither CI nor Sun Life assumes responsibility for any penalty taxes that may be charged to you.

At the time the legislation comes into effect and on the last business day of each month after that, if the cost of the foreign property in your registered plan exceeds the limit for foreign property, CI will rebalance your Clarica Portfolio. We will do this by selling enough units of the segregated funds that are considered foreign property to bring your foreign property to the prescribed limit. CI will then use the proceeds of the sale the same day to buy units in your highest valued 100% Canadian content fund. If you do not own a 100% Canadian content fund, the amount will be transferred to the Clarica SF CI Money Market Fund.

You will not have to pay deferred sales charges for any DSC class A units that are sold under the foreign content rebalancing service if you rebalance to DSC class A units of another segregated fund.

Because the asset allocation process is based on the market value of your Clarica Portfolio and the foreign content limit applies to the cost of the investments in your Clarica Portfolio, there's a chance that the asset allocation process could cause the foreign property in your registered plan to exceed the limit. If this happens, the foreign content rebalancing service will be triggered at the end of the month, so that the foreign property remains below the limit.

Fees and expenses

Fees and expenses paid by the segregated fund

Some fees and expenses are paid by the segregated funds. This reduces the value of the segregated funds.

Management fees and other expenses of the segregated funds

Management fees and other expenses vary for each segregated fund. Management fees are calculated daily and paid daily as an annualized percentage of the net asset value of each class of segregated fund. Other expenses are accrued daily and paid when they are due. For specific fees, see the table, *Management fees and other expenses*, starting below.

Management fees include insurance fees for the cost of the guarantees provided by Sun Life. Sun Life may change, from time to time, the insurance fee applicable to any fund or class in which you hold units by giving you written notice of the change at least 60 days in advance. If the change results in an insurance fee that exceeds the insurance fee limit referred to in the table, *Management fees and other expenses*, we'll give you the notice and rights described in *Fundamental Changes* on page 15.

We may also change the management fees that do not form part of the insurance fees, but if we do, we'll give you the notice and rights described in *Fundamental Changes* on page 15.

Other expenses that may be charged to the segregated funds include:

- audit fees, bank charges, interest expenses, custodial and safekeeping fees
- regulatory fees
- taxes, including the Goods and Services Tax (GST)
- any other expenses related to their investment activities
- legal costs, and

 investor and fund administration costs, including financial and tax reporting, and the preparation and distribution of this Information Folder.

The management expense ratios include the Goods and Services Tax (GST), interest charges and expenses that are allowed to be charged to the fund. The annual management fee of the fund and the annual insurance fee of each class of units of the fund do not include GST.

- deferred sales charges on DSC class A units for segregated funds
- 60 day exchange fee
- charge for NSF (not sufficient funds) cheques

You do **not** pay any additional fees or expenses for the following services:

- establishing a registered plan
- regular contribution plans (PACs)
- periodic income payments
- automatic exchanges
- asset allocation process
- foreign content rebalancing service.

Deferred sales charges

For more information, see Sales charges for segregated funds on page 14.

60 day exchange fee

CI may charge up to 2% of the amount you exchange or transfer. If you exchange units of any segregated fund, or sell them and transfer the proceeds to another financial institution, within 60 days of buying units in the same fund, we may charge this fee and deduct it from the proceeds of the units sold. We may also charge this fee if you transfer between investments or withdraw money from an investment and transfer it to another financial institution within 60 days of making a contribution. It does **not** apply to exchanges as a result of the asset allocation process or foreign content rebalancing service.

Charge for NSF (not sufficient funds) cheques

CI may charge up to \$25 for each cheque or payment that is returned to us. The fee is deducted from your Clarica Portfolio.

Sales charges for segregated funds

You may have to pay a sales charge when you invest in segregated funds. There are different types of sales charges and each has different management fees. The specific management fees for each sales

The sales charge you choose will also affect the compensation paid to your agent. For more information, see *Compensation paid to your agent* on page 15.

Each segregated fund offers both no-load units and deferred sales charge (DSC) units.

No-load units

If you choose the no-load option, you do not pay a sales charge when you buy or sell units.

Deferred sales charge or DSC class A units and redemption fees

The deferred sales charge option has redemption fees that you may pay at the time you make withdrawals from a segregated fund, except as provided below in this section. We reserve the right to change redemption fees from time to time. No sales charge amount is deducted from the amount of your premium.

Redemption fees are calculated as a percentage of the original cost to you of the units that you redeem from your contract. Please see Schedule of sales charges and redemption fees for more information regarding Redemption fees.

Redemption fees apply to any withdrawal, except as provided below in this section, including any withdrawal on contract termination, within the first seven years following the date of the deposit of the premium you pay.

If a redemption fee applies, it will be calculated beginning with the units within the segregated fund purchased by the earliest premium deposited to your contract. If you reset your guarantee or make segregated fund transfers, the age of your premium will not be affected for redemption fee purposes. Please see Optional services for more information on resetting your guarantee and Examples of how the segregated funds' guarantees work for more information on segregated fund transfers.

Fees and expenses (continued)

Free redemption withdrawals

Each year, you may redeem at no charge some of the units for which the deferred sales charge option applies, which would otherwise be subject to redemption fees. This is called your free redemption right.

The available numbers of units are calculated as follows:

- 10% of the number of deferred sales charge units purchased in the current calendar year, multiplied by the number of months remaining in the calendar year (including the month of purchase) divided by 12, plus
- 10% of the number of deferred sales charge units held on December 31 of the preceding year that are subject to the redemption fee.

We reserve the right to modify or discontinue your free redemption right at any time in our sole discretion.

Redemption fees apply in full for transfers to other financial institutions. Please see Transferring to another financial institution for more information on how withdrawals affect your guarantee.

There are no sales charges or redemption fees payable by you in respect of the underlying mutual funds. Any sales charges and redemption fees in respect of the segregated funds are not a duplication.

If you exchange DSC class A units of one segregated fund for DSC class A units of another segregated fund, the value of the new units that you exchange to will be considered to have been acquired during the calendar year that the units of the segregated fund you exchanged from were originally bought. This means that the percentage of the deferred sales charge will not increase when you exchange DSC class A units of one segregated fund for DSC class A units of another segregated fund. For more information, see *How to exchange investments within your Clarica Portfolio* on page 10.

The deferred sales charge will not be applied to withdrawals or exchanges which occur as a result of the annuitant's death.

Compensation paid to your agent

Sales commissions

There are no sales commissions paid to the agents when you buy noload units of segregated funds.

CI pays a one time sales commission to your agent when you buy DSC class A units of segregated funds.

Service fees

CI pays monthly service fees to agents for providing you with ongoing service. These fees are not an extra cost to you, or the segregated funds

Fundamental Changes

General information

If we wish to make any of the following Fundamental Changes, we'll notify you at least 60 days prior to making the change:

- we increase the management fee charged against the assets of any of the segregated funds in which you hold units;
- we change the fundamental investment objective of any of the segregated funds in which you hold units;
- we decrease the frequency with which we value units of any of the segregated funds in which you hold units;
- we increase the insurance fee charged against the assets of any
 of the segregated funds in which you hold units to an amount
 that is greater than the insurance fee limit for that fund specified
 in the table under Management fees and other expenses.

Your rights in the event of a Fundamental Change

Should we make one of the Fundamental Changes listed above to any of the segregated funds in which you hold units, we'll give you the right to:

- transfer the value of your units in the segregated fund affected by the Fundamental Change to a similar fund without incurring any redemption fees or similar charges; or
- if we do not offer a segregated fund similar to the fund affected by the Fundamental Change, redeem your units in the affected fund without incurring any redemption fees or similar charges.

Your right to elect either option is effective only if we receive your election within 5 business days prior to the end of the 60 day notice period. During this 60 day notice period, you may not transfer to a segregated fund subject to a Fundamental Change from a fund which is not subject to a Fundamental Change unless you agree to waive the right to redeem without incurring redemption fees or similar charges.

We also reserve the right to change underlying mutual funds. If such a change is a Fundamental Change, you will have the rights described above. Changing an underlying mutual fund to another substantially similar underlying mutual fund will not constitute a Fundamental Change provided immediately following the change the total management and insurance fee of the segregated fund is the same as, or lower than, its total management and insurance fee immediately before the change. A substantially similar underlying fund is one that has a comparable fundamental investment objective, is in the same investment fund category and has the same or lower management fee as the underlying fund it replaces. If we change an underlying mutual fund of a fund in which you hold units to a substantially similar underlying mutual fund, we will: (a) notify you, our regulators and the Canadian Life and Health Insurance Association Inc. at least 60 days in advance of the change (unless such notice is not practical in the circumstances, in which event we will provide notice as soon as reasonably practical), and (b) amend or refile this Information Folder to reflect the change. The foregoing may be superceded by any regulatory developments governing changes to underlying funds.

Your income tax considerations

This is a general summary of income tax considerations for owners of a Clarica Portfolio who are Canadian residents. You should consult your own tax advisor about your personal circumstances.

Taxation of non-registered plans

Segregated funds

We allocate segregated fund income to you annually.

Income net of fund expenses may contain capital gains or capital losses, Canadian dividends, Canadian interest, foreign income and other income. CI will send you a tax slip at the end of each year showing each type of income separately. You must report these amounts on your income tax return.

Income allocation will increase the adjusted cost base of your segregated fund holding to ensure these amounts are not taxed again on withdrawal. If the fund has a capital loss, the loss allocation will decrease the adjusted cost base of your segregated fund holding.

If you've withdrawn or exchanged units from a segregated fund, the withdrawal or exchange will result in either a capital gain or a capital loss. The capital gain or loss equals the difference between the market value of the units on the day of the withdrawal or exchange and the adjusted cost base. The capital gain or loss is combined with the capital gains or losses that the segregated fund has allocated to you on the same tax slip.

You must report capital gains or losses on your income tax return.

Changing an underlying mutual fund may result in a gain (or loss) being realized and allocated to you.

For example, let us assume:

- you contribute \$5,000 to a segregated fund
- at the end of the year, the segregated fund allocates income of \$300, which is made up of \$100 capital gain, \$100 interest and \$100 foreign income
- five months later, you contribute another \$1,000 to the segregated fund
- three months after that, you withdraw \$3,000 from the segregated fund.

The adjusted cost base per unit would work like this:

As the table shows, the following principles apply to calculating the adjusted cost base:

- the adjusted cost base per unit changes with every new contribution
- the adjusted cost base per unit changes with income allocation
- withdrawals do not affect the adjusted cost base per unit
- after a withdrawal the adjusted cost base of the remaining units is calculated by subtracting the adjusted cost base (and not the market value) of the units withdrawn.

We'll use the following formula to calculate the capital gain or loss on withdrawal or exchange:

- market value of the units withdrawn or exchanged
- minus the adjusted cost base of the units withdrawn or exchanged
- minus any costs of withdrawing or exchanging those units.

Using the example above, the capital gains on the withdrawal would be:

Market value of the units withdrawn	\$3,000.00
Adjusted cost base of units withdrawn (260.8696 x \$10.66)	(\$2,780.87)
Capital gain	\$219.13

Taxation of registered plans

You do not have to pay tax on any investment gains or interest in your RRSP, locked-in RRSP, LIRA, RRIF, LIF or LRIF because these plans are tax-sheltered until you make a withdrawal. You also don't have to pay tax on any fees that are deducted from your withdrawal amount. These fees include deferred sales charges, 60-day exchange fees and charges for NSF cheques. For more information about these fees, see Fees and expenses paid directly by you on page 14.

Transfers between different segregated funds will not have tax consequences, but they may affect the foreign content in your Clarica Portfolio. For more information about foreign content, see *Foreign content rebalancing service* on page 12.

Registered Retirement Savings Plans (RRSPs)

When cash contributions are made to an RRSP, CI (in the name of and on behalf of Sun Life) will issue an RRSP contribution receipt. If the contribution is made to a spousal RRSP, the RRSP receipt will show the names and social insurance numbers of both the owner of the Clarica Portfolio and the contributor. The contributor may claim the tax deduction for any contributions made.

If money is transferred from another RRSP or registered pension plan to an RRSP, we'll not issue an RRSP receipt because the transfer is considered a tax-sheltered transfer.

When you withdraw money from an RRSP, we will withhold tax from the amount you withdraw after any fees and expenses have been deducted. We'll also withhold more than the minimum tax required if you instruct us to do so. We'll send you a tax slip at the end of every year showing the total amount you've withdrawn and the total income tax we have withheld during that year. You must report these amounts on your income tax return.

Locked-in Registered Retirement Savings Plans (Locked-in RRSPs) and Locked-In Retirement Accounts (LIRAs)

According to provincial pension laws, you cannot make cash contributions to a Locked-in RRSP or a LIRA.

Pension laws in most provinces do not allow you to make cash withdrawals from a Locked-in RRSP or LIRA except under unusual situations. For more information, refer to the applicable provincial LIRA or locked-in provisions in Part D of the RRSP and LIRA contract starting on page 22.

Registered Retirement Income Funds (RRIFs), Life Income Funds (LIFs) and Locked-in Retirement Income Funds (LRIFs)

You're not allowed to make cash contributions to a RRIF, LIF or LRIF. You can only make contributions to these plans by way of a transfer from an RRSP, Locked-in RRSP or LIRA. We do not issue tax receipts for the amount being transferred because the transfer is considered a tax-sheltered transfer.

We'll not withhold tax on the government-required annual minimum that you withdraw as periodic income payments from a RRIF, LIF or LRIF. However, if the amount you withdraw is over the government required annual minimum, we will withhold tax on the amount over the minimum amount. We will also withhold more than the minimum tax required if you instruct us to do so. We send you a tax slip at the end of every year showing the total amount you've withdrawn and the total income tax we have withheld during that year. You must report these amounts on your income tax return.

CI and Sun Life keep the information you provided on your application form. We may share the information we collect from you with our affiliates. The information will be used mainly for administrative and regulatory compliance purposes, as well as to allow us to better understand your needs.

We have very strict policies prohibiting the disclosure of confidential client information to parties outside Sun Life Assurance Company of Canada, our affiliates and CI. You can be assured that your information will be kept in strict confidence.

Correspondence from us

When you buy, sell or exchange units, CI will send you a confirmation notice to help you keep track of your transactions. The confirmation notice includes the amount of each transaction, the number of units bought, sold or exchanged, and the unit prices used.

We don't send confirmation notices for the following transactions:

- buying units using a regular contribution plan (PAC)
- receiving periodic income payments, and
- exchanging units of segregated funds using an automatic exchange plan.

These transactions are included in your annual and semi-annual statements

CI will automatically send you statements in January and July. The annual statement in January reports the value of the investments you bought, sold or exchanged in the previous calendar year. The semi-annual statement in July reports the value of the investments you bought, sold or exchanged during the first six months of that year.

CI will send you all the required income tax slips.

CI will send you a Clarica Portfolio annual report every year within four months of the end of the year. The annual report includes the annualized rate of return for the segregated funds for 1, 3, 5 and 10-year periods, the segregated funds management expense ratio and the total management expense ratio. The report also includes audited financial statements for the segregated funds as at December 31.

Semi-annual unaudited financial statements of the segregated funds are also available upon request if received by October 31 of any year. You may address your requests to CI, CI Place, 151

Upon your request, we will send to you copies of the simplified prospectus, annual information folder, financial highlights and audited financial statements required for an underlying fund. Upon your request, we will send to you copies of the annual or the semi-annual unaudited financial statements for each underlying fund. You may choose to receive them in hard copy format or by electronic transmission.

Interest of management and others in material transactions

In the last three years, neither the principal broker nor any director or senior officer of Sun Life Assurance Company of Canada or any associate or affiliate of the foregoing persons or companies has had any material direct or indirect interest in any transactions or in any proposed transactions that would materially affect our segregated funds

Material contracts

Sun Life Financial Services of Canada Inc., Sun Life Assurance Company of Canada, Clarica Life Insurance Company, CI Fund Management Inc. and CI Mutual Funds Inc. entered into an Administrative Services Agreement dated as of July 25, 2002 pursuant to which Sun Life has retained CI to manage the day-to-day operations of the Clarica Portfolio. In the last two years, neither Sun Life Assurance Company of Canada nor its affiliates have entered into any other contracts that reasonably could be considered material to present or future owners of the Clarica Portfolio segregated funds other than contracts entered into in the ordinary and normal course of business.

Additional coverage

Sun Life Assurance Company of Canada is a member of the Canadian Life and Health Insurance Compensation Corporation (CompCorp).

Fund on fund investments

Certain underlying funds may invest in units of other mutual funds. The underlying funds which invest in other funds are called *top funds*. The other mutual funds which are invested in are called *bottom funds*.

A top fund may only invest in another fund if the investment is consistent with the top fund's investment objectives. Buying units of another mutual fund allows the top fund to invest indirectly in foreign equity markets cost effectively. The top funds' investments, including units of the bottom fund, must comply with the foreign property limits set by the *Income Tax Act* (Canada).

To avoid the duplication of management fees, when the management fees for the top funds are calculated, the net asset value of the top fund does not include any units they own of a bottom fund.

The top fund may only invest up to 10% of its net assets, at the time it makes the investment, in units of the bottom mutual fund.

The top fund cannot buy units of a bottom fund if it would result in:

- the top fund owning more than 10% of the outstanding units of the bottom fund, or
- the top fund together with any related funds owning more than 20% of the outstanding units of the bottom fund.

The risks of investing in segregated funds

General risk factors

The market value of the investments that make up the portfolio of the underlying fund changes from day to day. As a result, the unit price of each segregated fund goes up and down with these changes. The market value of the underlying fund's investments can be affected by many different factors, including:

- general economic and political conditions
- general stock market conditions
- news about the governments or companies that issue the securities.

In limited circumstances, you may not be able to sell your units exactly when you want to because the right of the underlying funds to sell their units may have been temporarily suspended. For more information, see *How to make withdrawals from your Clarica Portfolio* on page 9.

Risks that apply to specific segregated funds

In addition to the general risks outlined above, there are additional risks that may apply to some of the underlying funds. These are:

- interest rate risk
- · credit risk
- liquidity risk
- foreign exchange risk
- foreign investment risk
- bottom fund risk
- class risk
- concentration risk
- government regulation risk
- short selling risk
- small capitalization risk
- risk of investing in fixed income investments
- risk of investing in equities
- risk of investing in derivatives
- risk of securities lending
- risk of repurchase and reverse repurchase agreements
- segregated funds with more than one class of units.

Which of these risks apply to the underlying fund, as well as any additional risks specific to that fund, are explained under *What are* the risks of investing in the fund? in each fund description starting on page 23.

Interest rate risk

The value of fixed income securities can fluctuate as interest rates change. Generally, as interest rates fall, the underlying fund's unit price will go up. On the other hand, when interest rates rise, the underlying fund's unit price can be expected to fall.

Credit risk

Some of the securities in the underlying fund's portfolio may be at risk if the government or company who issued the security fails to repay the principal, interest or both. If this happens, the underlying fund could lose money and the underlying fund's unit price may fall.

Liquidity risk

Liquidity risk is the ease with which an investment may be converted to cash at a reasonable price. It may be difficult to buy or sell some of the securities in the underlying fund's portfolio because the government or company who issued the security is not well known or because economic, political and stock market conditions are not favourable. This means these securities are less liquid and, as a result, their value may rise and fall significantly, affecting the unit price of the underlying fund.

Foreign exchange risk

Changes in the value of foreign currencies affect the performance of an underlying fund. If the Canadian dollar goes down relative to foreign currencies, the value of the investments held in those countries goes up. This results in an increase in the underlying fund's unit price. On the other hand, if the Canadian dollar strengthens relative to foreign currencies, the underlying fund's unit price will go down.

Foreign investment risk

Underlying funds that invest in securities in other countries will be affected by several factors:

- general economic and political conditions in those countries
- in some countries, accounting, auditing, financial reporting and other disclosure rules may be less stringent than in Canada
- in some countries, foreign custodians may not provide as high a level of security as is provided in Canada
- the risk of foreign investment controls, foreign exchange controls or other foreign laws that result in the confiscation of assets.

Bottom fund risk

Some underlying funds may have one or more other large investors or may invest in units or shares of another mutual fund which has large investors (the mutual fund with the large investors being called the *bottom fund*). Any significant transaction made by a large investor could significantly impact the bottom fund's cash flow. If a large investor buys a large amount of units or shares of the bottom fund, the bottom fund could temporarily have a high cash balance. If a large investor redeems a large amount of its investment in the bottom fund, the bottom fund may have to sell its investments at unfavourable prices to meet the redemption requests. This can reduce the returns of the bottom fund.

Class risk

Underlying funds sometimes issue different classes of units of the same underlying fund. Similarly, some underlying funds are structured as different classes of shares of the same mutual fund corporation. Each class has its own fees and expenses, which the underlying fund tracks separately. However, if one class is unable to meet its financial obligations, the other classes are legally responsible for making up the difference.

Concentration risk

Some of the underlying funds may concentrate their investments in a relatively small number of securities, certain sectors or specific regions or countries. This may result in higher volatility, as the value of the portfolio will vary more in response to changes in the market value of these securities, sectors or regions or countries.

Government regulation risk

Government policies or regulations are more prevalent in some sectors than in others. Underlying funds that invest in these sectors - such as health sciences or telecommunications - may be affected when these regulations or policies change.

Short selling risk

Certain underlying funds may engage in a disciplined amount of short selling. A "short sale" is where an underlying fund borrows securities from a lender and then sells the borrowed securities (or sells short the securities) in the open market. At a later date, the same number of securities are repurchased by the underlying fund and returned to the lender. In the interim, the proceeds from the first sale are deposited with the lender and the underlying fund pays interest to the lender. If the value of the securities declines between the time that the underlying fund borrows the securities and the time it repurchases and returns the securities, the underlying fund makes a profit for the difference (less any interest the underlying fund pays to There is no Short selling involves certain risks. assurance that securities will decline in value during the period of the short sale sufficient to offset the interest paid by the underlying fund and make a profit for the underlying fund, and securities sold short may instead increase in value. The underlying fund may also experience difficulties repurchasing and returning the borrowed securities if a liquid market for the securities does not exist. The

The risks of investing in segregated funds (continued)

lender from whom the underlying fund has borrowed securities may go bankrupt and the underlying fund may lose the collateral it has deposited with the lender. Each underlying fund that engages in short selling generally will adhere to controls and limits that are intended to offset these risks by selling short only securities of larger issuers for which a liquid market is expected to be maintained and by limiting the amount of exposure for short sales. The underlying funds also will deposit collateral only with lenders that meet certain criteria for creditworthiness and only up to certain limits.

Small capitalization risk

Capitalization is a measure of the value of a company. It is the current price of a company's stock, multiplied by the number of shares issued by the company. Companies with small capitalization may not have a well-developed market for their securities. As a result, these securities may be difficult to trade, making their prices more volatile than those of large companies.

Risk of investing in fixed income investments

The underlying fund's unit price will be affected by the average term to maturity of the underlying fund's investment portfolio. The longer the average term to maturity, the more volatile the market value will be if there's a change in interest rates.

Risk of investing in equities

The value of equities is affected by economic, political and stock market conditions as well as the outlook for the company that issued the security. Generally, if these factors are favourable, the value of the security, and the underlying fund's unit price, will rise. On the other hand, if these factors are unfavourable, the value of the security, and the underlying fund's unit price, will fall.

Risk of investing in derivatives

A derivative is a contract whose value is based on, or derived from, a separate investment such as a stock, bond, foreign currency or market index. A derivative can be bought and sold like an investment, but it's not a direct investment in the underlying security.

Underlying funds often use derivatives for hedging. This means they are used to protect the underlying fund against the changes in the value of a stock, bond, foreign currency or market index. Funds sometimes use derivatives instead of making a direct investment in the underlying security.

There are several risks associated with investing in derivatives:

- one party in a derivative contract may not be able to honour its obligation and the underlying fund could lose money
- when derivatives are used for hedging, there's no guarantee that the hedging strategy will work or that losses will be avoided
- when derivatives are used for hedging, the underlying securities in the portfolio will still change in value
- derivatives could limit the amount of gain, if the value of the underlying investment rises, because the cost of the derivatives would offset the gain
- for derivatives that are options, futures or forward contracts, there's no guarantee that the underlying fund will be able to sell those derivatives when it wants, which could result in a loss for the underlying fund
- for derivatives that are options or futures contracts, there may be daily trading limits which might prevent the underlying fund from selling the derivatives when it wants, which could result in a loss for the underlying fund
- derivatives traded in smaller foreign markets may be less liquid and have greater credit risk than derivatives traded in Canada
- for derivatives that are linked to an index, if trading is halted in the stocks or bonds that are included in the index, the price of those derivatives might be distorted or trading in the derivatives might also be halted. This could mean a loss for the underlying fund.

Risk of securities lending

Securities lending is when a fund lends some of its investments to qualified borrowers in exchange for fees or interest.

The underlying fund's custodian would hold qualified collateral from each borrower. If cash collateral is provided, the underlying fund keeps a portion of the interest earned on the investment of the cash collateral. Where non-cash collateral is provided, the underlying fund receives a fee from the borrower.

The underlying fund continues to receive any interest, dividends or other distributions paid on the investment loaned. The loan may be terminated by the underlying fund at any time. Where the loan is terminated the investment loaned will be returned to the underlying fund in accordance with standard settlement procedures.

Since securities lending is a means of extending credit, if the borrower becomes insolvent, there may be a delay in recovering the securities and the underlying fund may lose voting and other rights on the securities loaned.

To minimize the risk of securities lending, the market value of the collateral held by the underlying fund at the end of each business day must not be less than 102% of the market value of the investment being loaned.

Risk of repurchase and reverse repurchase agreements

A repurchase agreement takes place when investments are sold by the fund for cash and the fund agrees to repurchase the investment back from the purchaser at a specific date and at a higher price. A reverse repurchase agreement is when the fund buys an investment at one price and agrees to sell it back to the same person at a specific date and at a higher price.

For a repurchase agreement there is a risk that if the purchaser cannot complete the agreement, the underlying fund may not be able to acquire the investment at a price equivalent to the price in the repurchase agreement and there may be a delay acquiring the investment.

For a reverse repurchase agreement there is a risk that if the other person cannot complete the agreement, the underlying fund may be left holding the investment. The underlying fund may be at risk in this situation, if the value of the investment has dropped since the agreement was entered into.

To minimize the risk of repurchase agreements, the underlying fund holds collateral from the purchaser and the market value of the collateral held by the underlying fund at the end of each business day must not be less than 102% of the market value of the investment sold. To minimize the risk of reverse repurchase agreements, the market value of the investment held by the underlying fund at the end of each business day must not be less than 102% of the collateral paid for the investment.

Segregated funds with more than one class of units

All our segregated funds have both no-load class units and DSC class A units. The investments of the segregated fund are the same for both classes. However, the unit prices may be different because sales charges and management fees, which are different for each class, affect the unit price. It's possible that a segregated fund may not be able to pay the expenses of one class of units using that class' proportionate share of the assets. If that were to happen, the segregated fund would have to pay the expenses of that class out of the other assets of the segregated fund. For more information, see Sales charges for segregated funds on page 14.

An explanation of some terms used in this Information Folder

adjusted cost base

The total dollar amounts spent to buy units in the segregated fund, including any sales charges paid at the time you bought your units: **plus** the amount of income allocated

minus the adjusted cost base of any units you've already sold.

affiliate

A person or group closely related to an organization.

annuitant

The person insured under the plan, also called the *insured person*. For registered plans, the owner of the plan must be the annuitant.

Asian equity fund

A mutual fund that invests primarily in common shares of companies in Asia.

balanced fund

A mutual fund that has an investment policy of *balancing* its portfolio, generally by including bonds and shares in varying proportions according to its investment objectives.

beneficiary

The person, persons or estate you name in writing to receive any death benefit when the insured person dies.

bottom-up

An investment management approach that focuses on the best securities for the portfolio. The portfolio advisors assess each company based on a range of criteria such as the quality of management, financial resources available to achieve its objectives, corporate strategies and tactics, the quality of products, and market acceptance.

business day

Any day The Toronto Stock Exchange and CI's head office is open for business.

Canadian equity fund

A mutual fund that invests primarily in common shares of Canadian companies.

Canadian resources equity fund

A mutual fund that invests primarily in common shares of Canadian companies engaged in the discovery, development or extraction of oil, gas and metals.

capital gain

The difference between what an investment is sold for, after paying any costs of selling it, and the investment's adjusted cost base. If the investment is sold for more than the adjusted cost base, you realize a capital gain.

capital loss

The difference between what an investment is sold for, after paying any costs of selling it, and the investment's adjusted cost base. If the investment is sold for less than the adjusted cost base, you realize a capital loss.

CLHIA

Canadian Life and Health Insurance Association Inc. (CLHIA), the national trade association of life and health insurance companies in Canada. CLHIA has issued guidelines detailing the form and content of information related to segregated funds.

contribution set date

January 1 of the year you invest money in your Clarica Portfolio.

contribution maturity date

January 1 ten years after the contribution set date or after the date you reset your contribution set date.

COS

The dollar amount spent to buy units of a fund.

deferred sales charge or DSC units

Segregated fund units that don't charge a fee to buy them. However, you may pay a sales charge when you sell the units within seven years of buying them.

derivative

A contract whose value is based on, or derived from, a separate investment such as a stock, bond, foreign currency or market index. A derivative can be bought and sold like an investment, but it's not a direct investment in the security.

emerging market

A market in any country that has:

- a low or middle income economy, or
- a total market capitalization of less than 3% of the Morgan Stanley Capital International World Index (an index that measures the performance of a broad selection of world equity markets).

European equity fund

A mutual fund that invests primarily in common shares of European companies.

fixed-income investments

Investments that generate a fixed amount of income that does not vary over the life of the investment.

fixed income fund

A mutual fund that invests primarily in fixed-income investments.

foreign equity fund

A mutual fund that invests primarily in common shares of non-Canadian companies.

forward contract

A contract to buy or sell a specific amount of a certain commodity at a fixed price at a future date.

Fundamental Change

An increase in the management fee charged against the assets of a segregated fund; a change in the investment objective of a segregated fund; a decrease in the frequency with which we value the units of a segregated fund; or an increase in insurance fee charged against the assets of a segregated fund to an amount that is greater than the prescribed limit.

future

An agreement to buy or sell a specified quantity of a commodity at a fixed price at a future date. These are specific types of forward contracts that are traded on securities exchanges.

guaranteed minimum value

On or after a contribution maturity date, the greater of:

- 75% of your contributions (including any growth locked-in by virtue of prior resets) attributed to that contribution set date, adjusted for withdrawals and exchanges, or
- the market value, at the time you exercise your guarantee, of the portion of your segregated funds units attributed to that contribution set date.

An explanation of some terms used in this Information Folder (continued)

hedging

Using derivatives or other investments to protect the fund against the changes in value of a stock, bond, foreign currency or market index.

insured person

The person insured under the plan, sometimes called the *annuitant*. For registered plans, the insured person must be the owner of the plan. For non-registered plans, the insured person can be the owner of the plan or another person chosen by the owner of the plan.

Life Income Fund (LIF)

A life income fund similar to a RRIF but subject to pension regulations. It's a plan that can be used to convert investments in a Locked in RRSP or a LIRA to a steady stream of income. Once funds are in an LIF, you must withdraw at least the minimum specified by the Income Tax Act (Canada). There is a limit on the maximum amount you can withdraw each year.

Locked-In Retirement Account (LIRA)

A locked-in retirement account similar to an RRSP but subject to pension regulations. It's a tax-deferred plan that allows you to invest money until age 69. Cash contributions are not accepted.

Locked-in Retirement Income Fund (LRIF)

A locked-in retirement income fund similar to a RRIF but subject to pension regulations. It's a plan that can be used to convert investments in a Locked in RRSP or a LIRA to a steady stream of income. Once funds are in a LRIF, you must withdraw at least the minimum specified by the Income Tax Act (Canada). There is a limit on the maximum amount you can withdraw each year.

management expense ratio

The total of all fees and expenses that the segregated fund must pay during the period expressed as an annualized percentage of the average net assets of the underlying fund and the segregated fund during the period. The management expense ratio varies from one fund to another.

management fee

A fee paid by the fund for management services related to the operation of the segregated fund.

maturity

The date when a loan, bond or debenture comes due and must be redeemed or paid off.

mortgage fund

A mutual fund that invests primarily in mortgages on real estate located in Canada.

mutual fund

A fund that invests in a variety of other investments and is managed by a professional portfolio advisor.

net asset value

The value of the segregated fund's total assets less its total liabilities.

net asset value per unit

The net asset value of a segregated fund divided by the number of units outstanding. It's also known as the unit price.

no-load units

Units of a segregated fund that don't charge a fee to buy or sell them.

option

The right or obligation to buy or sell a specified quantity of a security at a fixed price within a stipulated time.

payout annuity

An investment that provides you with a series of guaranteed payments for a specified number of years after retirement, for your lifetime, or for the lifetime of both you and the joint annuitant. The amount of the payments depends on your age, the amount of money invested and the type of annuity selected.

portfolio turnover rate

An indicator of how actively the fund's portfolio advisor trades the fund's investments. If the fund bought and sold all of its investments once during the year, it would have a portfolio turnover rate of 100%. The higher a fund's portfolio turnover rate in a year:

- the more the fund must pay during the year for costs associated with trading, and
- the greater the chance the fund will generate taxable capital gains or losses in that year.

There is not necessarily a relationship between a high turnover rate and the performance of a fund.

registered plan

A tax-sheltered plan that is a Registered Retirement Savings Plan (RRSP), Locked in RRSP, Locked-In Retirement Account (LIRA), Registered Retirement Income Fund (RRIF), Life Income Fund (LIF) or Locked-in Retirement Income Fund (LRIF).

Registered Retirement Income Fund (RRIF)

A plan that can be used to convert investments in an RRSP to a steady stream of income (Funds in an RRSP must be either withdrawn or converted to such a plan, no later than December 31 of the year you turn 69.) Once funds are in a RRIF, each year you may withdraw as much as you like, however, you must withdraw at least the minimum specified by the Income Tax Act (Canada).

Registered Retirement Savings Plan (RRSP)

A tax-deferred plan that allows you to invest money within certain limits until age 69. Contributions are deductible from your taxable income and can grow tax-free.

subsidiary

A company owned and controlled by another company.

term to maturity

The time until a loan, bond or debenture comes due and must be redeemed or paid off.

top-down

An investment management approach that looks at a market or country in general to see if there are favourable opportunities for investing.

treasury bill (T-bill)

Short-term government debt that doesn't pay interest, but are sold at a discount. The difference between the discounted price and the face (or par) value is the return you receive on your investment.

underlying fund

A mutual fund in which a segregated fund invests.

unit price

The price at which units of the segregated funds are bought, exchanged and sold. It's the fund's net asset value divided by the number of units outstanding. The unit price is also known as the net asset value per unit.

U.S. equity fund

A mutual fund that invests primarily in common shares of companies in the United States.

Clarica SF Alpine Canadian Resources Fund (Inception Date: January 1998)

To invest all of its net assets in units of Clarica Alpine Canadian Resources Fund or another substantially similar mutual fund.

Investment Policy of the Segregated Fund

Underlying Fund

Clarica Alpine Canadian Resources Fund

Investment Objective of the Underlying Fund

To provide long-term capital growth. The underlying fund will invest mainly in equity securities of Canadian companies engaged in the discovery, development or extraction of oil, gas or metals.

Investment Policy of the Underlying Fund

The portfolio adviser uses a bottom-up growth style of investing. It uses the following strategies to achieve the fund's investment objectives:

- a focus on small to large-size companies associated with the natural resource industry. The portfolio adviser chooses what it believes are the best companies for the portfolio, looking for those with a growth management style and good growth prospects
- a relatively high number of holdings allows the portfolio adviser to invest in small and mid-size companies in a specific market sector without substantially increasing the risk commonly associated with these types of companies
- investing in companies outside of Canada to access sectors of the market that are not adequately represented in Canada. The fund may invest in foreign stocks up to the limit allowed.
- investing in stocks for the long term, using a 'buy and hold' philosophy.

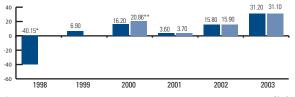
Performance

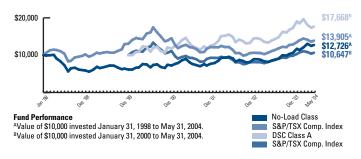

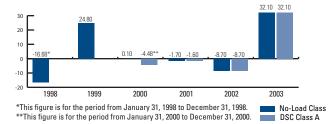

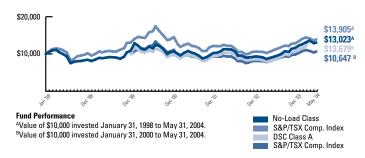
Year-by-year returns of the Segregated Fund (%)

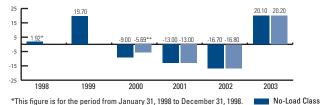

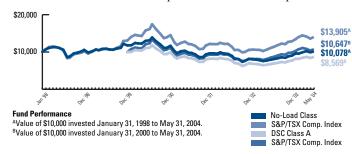
Year-by-year returns of the Segregated Fund (%)

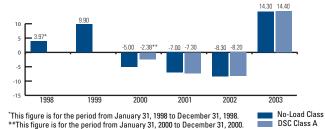

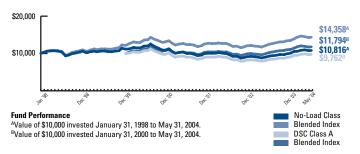
Year-by-year returns of the Segregated Fund (%)

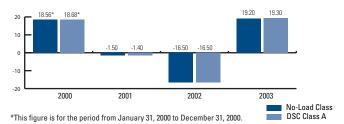

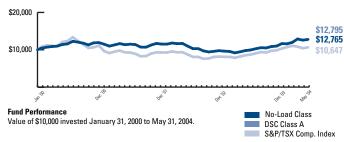
Year-by-year returns of the Segregated Fund (%)

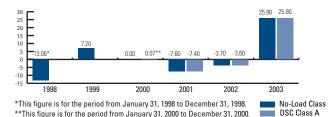

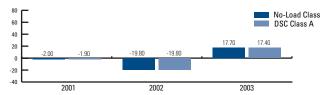

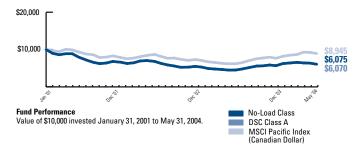
Year-by-year returns of the Segregated Fund (%)

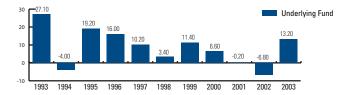

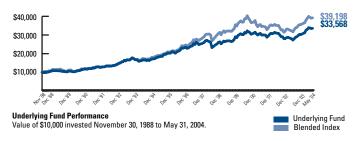

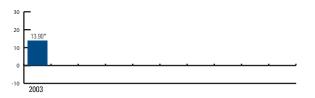

Year-by-year returns of the Segregated Fund (%)

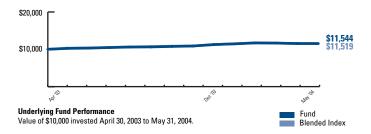

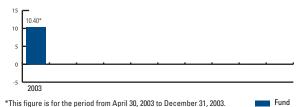

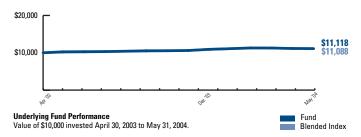
Year-by-year returns of the Segregated Fund (%)

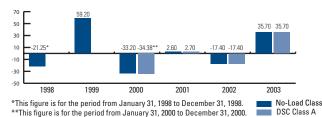

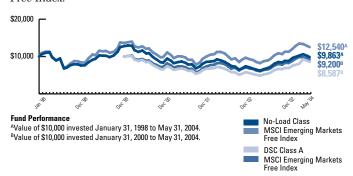
Year-by-year returns of the Segregated Fund (%)

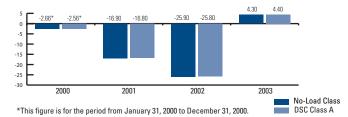

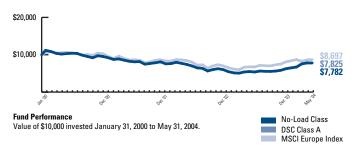
Year-by-year returns of the Segregated Fund (%)

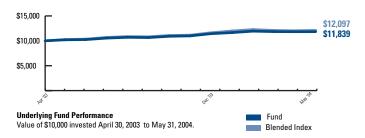

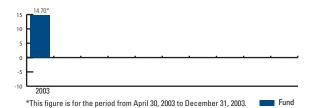

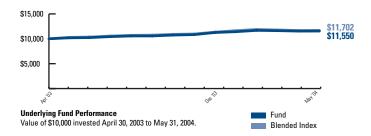
Year-by-year returns of the Segregated Fund (%)

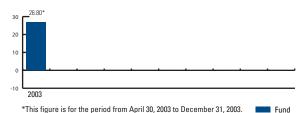

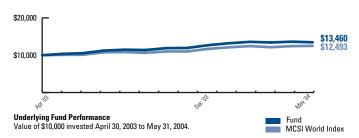
Year-by-year returns of the Segregated Fund (%)

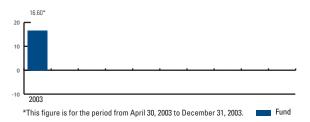

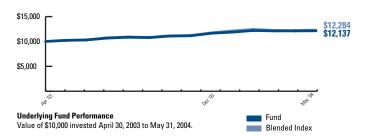
Year-by-year returns of the Segregated Fund (%)

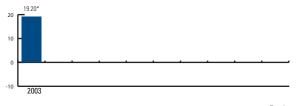

Year-by-year returns of the Segregated Fund (%)

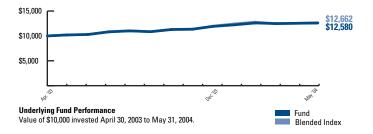

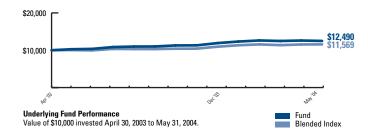

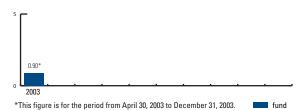

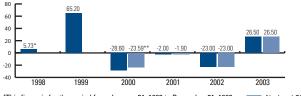

Year-by-year returns of the Segregated Fund (%)

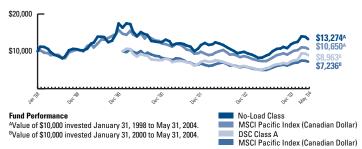

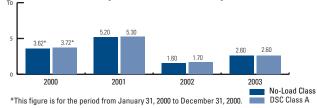

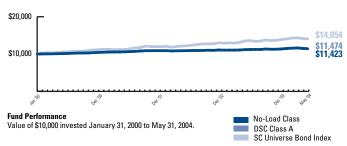
Year-by-year returns of the Segregated Fund (%)

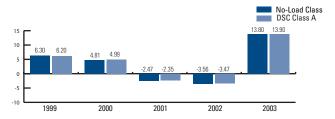

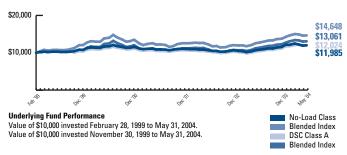
Year-by-year returns of the Segregated Fund (%)

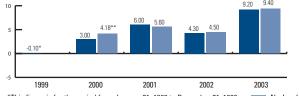

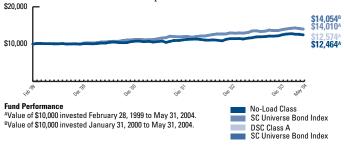

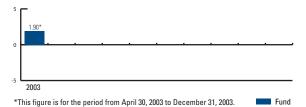

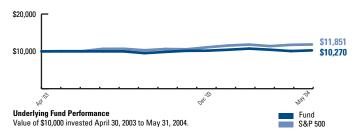
Year-by-year returns of the Segregated Fund (%)

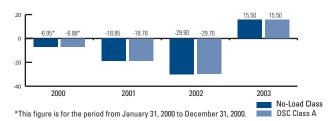

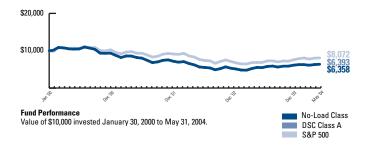
Year-by-year returns of the Segregated Fund (%)

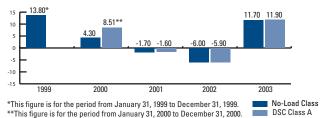

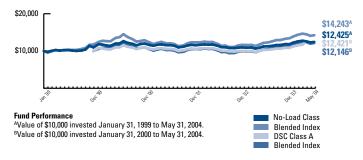
Year-by-year returns of the Segregated Fund (%)

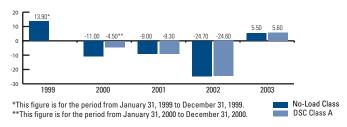

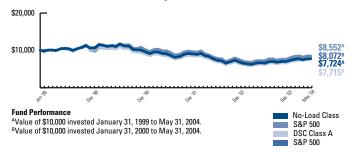
Year-by-year returns of the Segregated Fund (%)

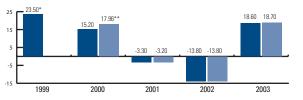

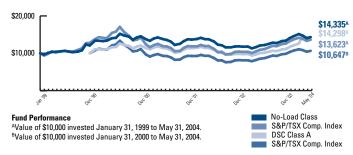

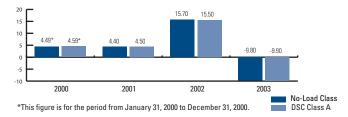

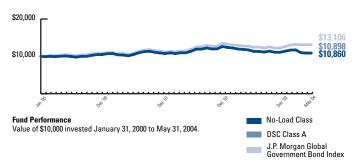
Year-by-year returns of the Segregated Fund (%)

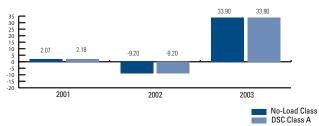

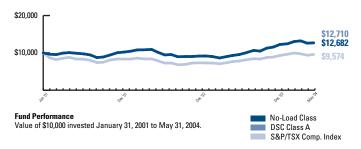
Year-by-year returns of the Segregated Fund (%)

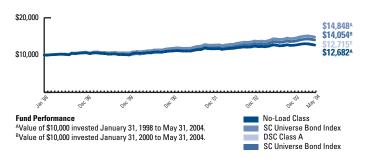
Year-by-year returns of the Segregated Fund (%)

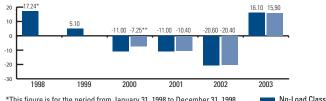

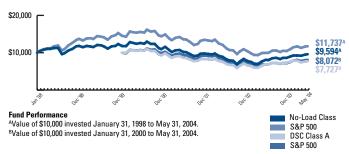

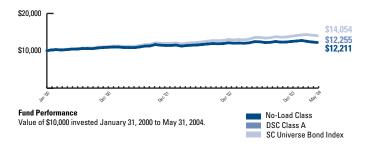
Year-by-year returns of the Segregated Fund (%)

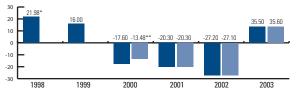

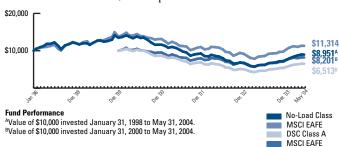

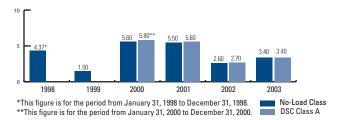

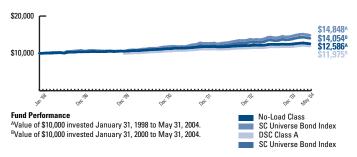
Year-by-year returns of the Segregated Fund (%)

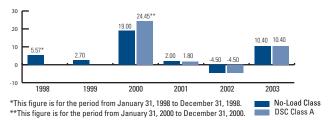

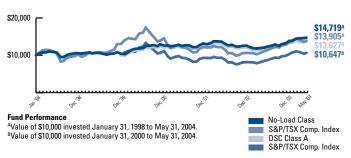
Year-by-year returns of the Segregated Fund (%)

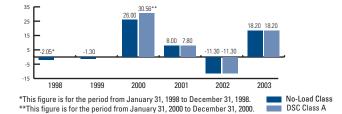

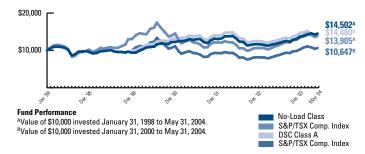
Year-by-year returns of the Segregated Fund (%)

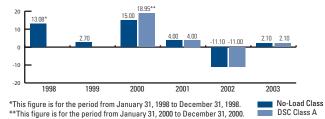

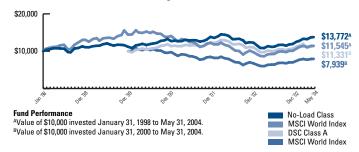
Year-by-year returns of the Segregated Fund (%)

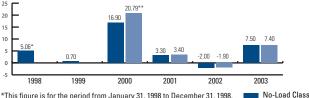

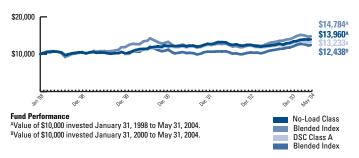

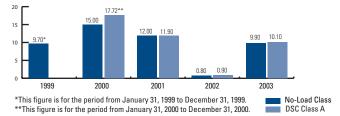

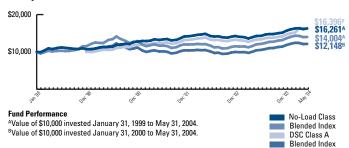
Year-by-year returns of the Segregated Fund (%)

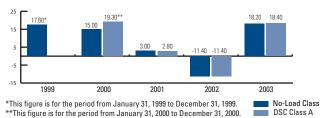

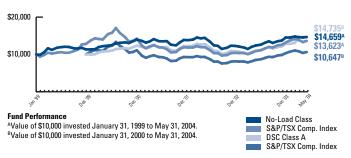
Year-by-year returns of the Segregated Fund (%)

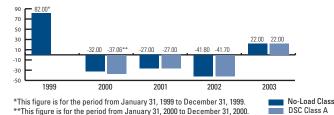

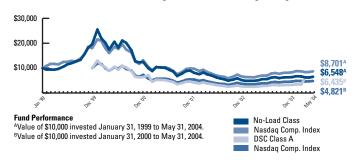
Year-by-year returns of the Segregated Fund (%)

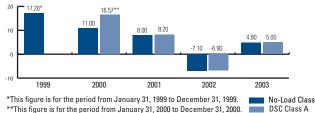

Year-by-year returns of the Segregated Fund (%)

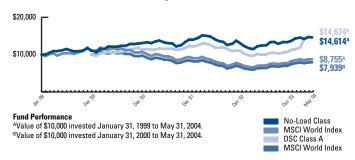

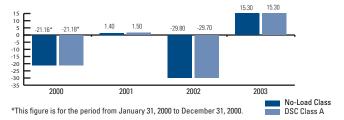

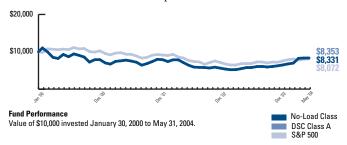
Year-by-year returns of the Segregated Fund (%)

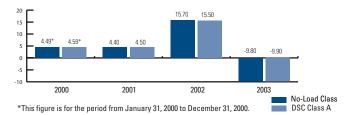

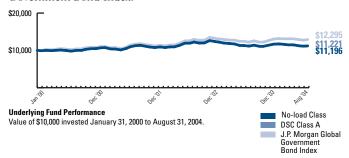
Year-by-year returns of the Segregated Fund (%)

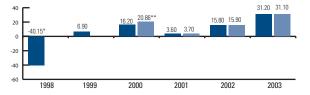

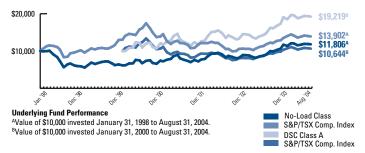
