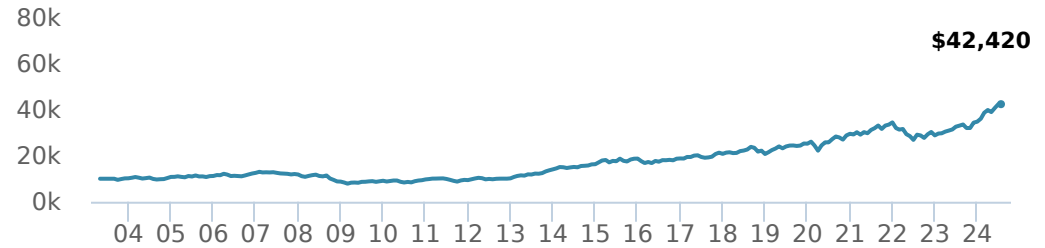

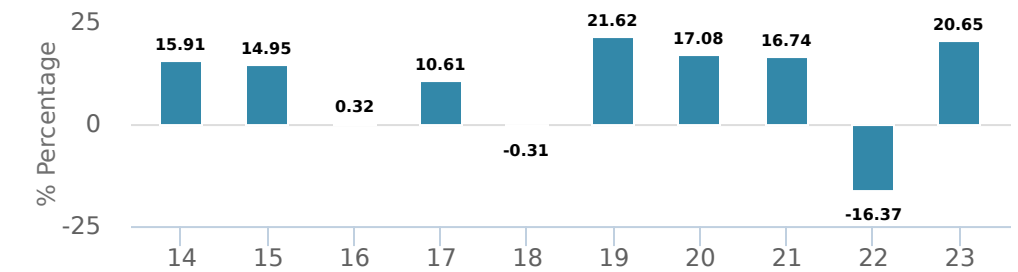

### Calendar year performance

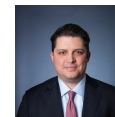
