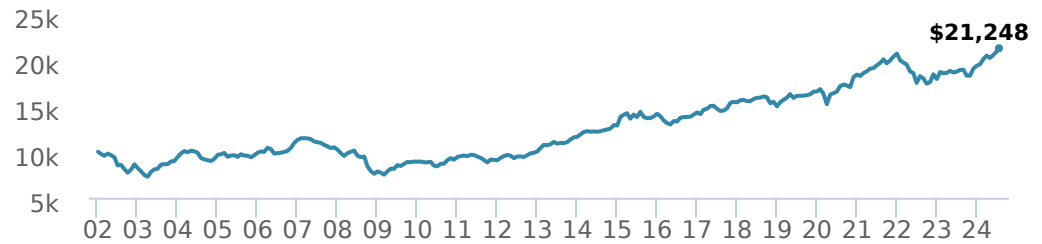

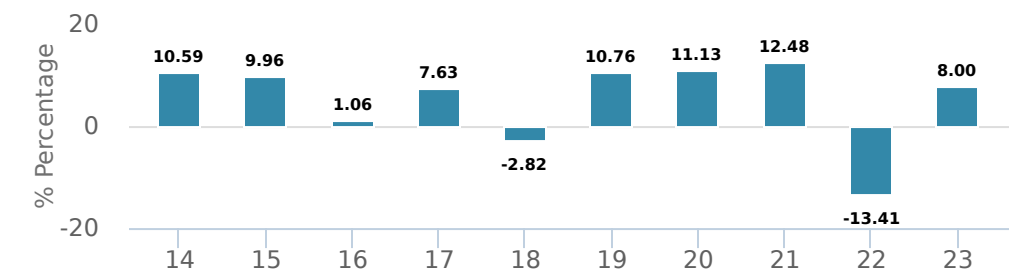

### Calendar year performance

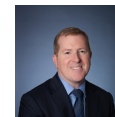

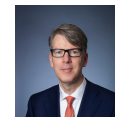
