

Important Tax Notice to U.S. Securityholders*

This combined statement is provided to securityholders who are United States persons for purposes of the U.S. Internal Revenue Code of 1986, as amended ("IRC") and the regulations thereunder. It is not relevant to other securityholders.

Sentry Growth and Income Portfolio (the "Fund") may be deemed to be classified as a Passive Foreign Investment Company ("PFIC") as defined in Section 1297(a) of the IRC for the year ending December 31, 2016 and thus, its securityholders are securityholders of the PFIC.

We recommend that all U.S. taxpayer clients consult a tax advisor concerning the overall tax consequences of their ownership of securities of the Fund and their U.S. tax reporting requirements. You can also find information on U.S. tax rules applicable to investments in a PFIC on the IRS website, www.irs.gov, by searching "Form 8621 Instructions".

Please find the attached Combined PFIC Annual Information Statement ("AIS") for the Fund. The PFIC AIS is being provided pursuant to the requirements of Treasury Regulation §1.1295-1(g)(1). The PFIC AIS contains information to enable you, should you so choose based on the advice of your tax advisor in light of your personal tax circumstances, to elect to treat the Fund as a qualified electing fund ("QEF").

Generally, an election is filed for each mutual fund for which you wish to make a QEF election. Because the Fund holds securities of one or more underlying mutual funds, you are receiving a Combined PFIC AIS containing information that will enable you to elect to treat any or all of the funds as a QEF as you choose, as well as information relating to your securities and values in your indirect holdings.

Please be aware that cash and property distributions reported on the PFIC AIS are converted into U.S. dollars based on the U.S. Federal Reserve spot rate in effect on the date the distribution is paid. We recommend that clients who do not file U.S. federal income tax returns on a cash basis consult their tax advisors regarding the appropriate U.S. dollar conversion rate.

Note that the information attached with this letter is intended to help you make one or more QEF elections, if you decide to do so, and neither such information nor this letter constitutes tax advice. The taxpayer should seek advice based on their particular circumstances from an independent tax advisor.

Example 1: On January 1, 2016, you acquired 10,000 units of Series A which earned \$0.30313 ordinary earnings per unit and \$0.00984 net capital gains per unit, and held them throughout the year. Your pro-rata share of Series A's ordinary earnings and net capital gains would be US\$3,031.30 (i.e., 10,000 units x \$0.30313) and US\$98.40 (i.e., 10,000 units x \$0.00984) respectively.

Example 2: On April 1, 2016, you acquired 10,000 units of Series B which earned \$0.29379 ordinary earnings per unit, and \$0.01310 net capital gains per unit, and held them throughout the remainder of the year (275 days). Your pro rata share of Series B's ordinary earnings and net capital gains per unit would be US\$2,207.44 (i.e., 10,000 units x \$0.29379 x 275/366) and US\$98.43 (i.e., 10,000 units x \$0.01310 x 275/366) respectively.

Example 3: On August 1, 2016, you acquired another 2,000 units of Series A in addition to the 10,000 units in example 1 and held 12,000 units for the remainder of the year, (153 days.) Your total pro-rata share of Series A's ordinary earnings would be US\$3,284.73 (\$3,031.30 + (2,000 units x \$0.30313 x 153/366)). Your total pro-rata share of Series A's net capital gains would be US\$106.63 (\$98.40 + (2,000 units x \$0.00984 x 153/366)).

Example 4: On January 1, 2016 you acquired 10,000 units of Series P which earned \$0.66147 ordinary earnings per unit and \$0.03958 net capital gains per unit, and held them through April 1, 2016 (91 days). On April 1, your Series P securities were re-designated as Series A securities and you acquired 10,000 units of Series A which earned \$0.30313 ordinary earnings per unit and \$0.00984 net capital gains per unit, and held them throughout the remainder of the year (275 days). Your total pro-rata share of Series P and Series A's ordinary earnings would be US\$3,922.10 ((10,000 units x \$0.66147 x 91/366)+(10,000 units x \$0.30313 x 275/366)). Your total pro-rata share of Series P and Series A's net capital gains would be US\$172.34 ((10,000 units x \$0.03958 x 91/366)+(10,000 units x \$0.00984 x 275/366)).
